Central Laboratory Expansion – Annual Update

Targeted & Achieved Milestones

• A/E Contract Executed:

Tower Pinkster (with HOK, CMTA, Brown + Kubican, and Element Design) contracted on **September 24, 2024**.

Pre-Design Completed (Dec 2024):

Programming confirmed, and conceptual design developed. Additional Radiation Health and Drug & Supplement Testing sections included. Southern site location selected, coordination with central utility plant for system capacity.

Phase A – Schematic Design (Completed March 2025):

Lab planning and section coordination; preliminary code review with KY HBC.

Phase B – Design Development (Completed September 2025):

Final programming check, discipline-level DD packages, MEP basis of design, lighting, specs, and cost estimate creation.

Phase C – Construction Documents (Upcoming; to complete May 2026):

To begin code compliance coordination and CM/GC procurement support; initiate furniture planning.

Expenditures to Date

Contracted Design Services: \$16,011,909

Challenges & Mitigation Strategies

Construction phasing and site logistics:

Site evaluated to ensure uninterrupted lab operations; northern loop road to be rerouted for deliveries.

Hazardous materials compliance:

Control areas planned to meet code requirements; inventory coordinated with DLS.

Complexity of program and building systems:

Regular work sessions with lab sections and code agencies to anticipate and resolve technical issues.


