RE: KRS 196.031 Annual Report

As part of HB 463 implementation, KRS 196.031 requires annual tracking of several items for incarcerated and supervised offenders. Please find the Department's report as outlined below.

While the Department of Corrections has significantly improved the capacity to track data since the passage of HB 463 in 2011, areas remain where the Department currently cannot provide information.

Placement and Recidivism


Recidivism rates for six (6) months, one (1) year, and three (3) years, as required by KRS 196.031(2)(j)(5).

- 9,098 (65%) of 14,088 offenders with approved discharge plans had release plans to a home placement (*i.e.* a non-halfway house placement).
- 10,912 (70%) of 15,635 post-incarceration supervised offenders have been in their current home placement for more than six (6) months.

Ten-Year Kentucky Prison Population Projection, FY2017 – 2027 JFA Associates, updated November 2017



At the end of FY2019, the state inmate population was 24,223, reflecting targeted efforts to reduce entrance to prison through violations of supervision.



FY16-18 consensus blended population (adjusted for HB303 enacted) projections are included for December 2015 – June 2018. FY18-20 consensus blended population projections are included starting with July 2018.

The Department works to aggressively manage the inmate population and meet the needs of a changing inmate population. Current population needs surround the controlled intake population and shortage of secure custody prison beds. Additional prison beds would alleviate the controlled intake inmate population in jails that are pending admission to prison, providing much needed relief in jail population overcrowding.

Personnel

The Department of Corrections continues to experience severe staffing shortages. The Department's turnover rate for 2018 was 22%, a 1% increase from 2017, despite focused efforts in this area. Corrections is a high stress work environment, with salary compensation commensurate with civil service. With additional competing job opportunities in certain locales, recruitment and retention is a challenge.

Currently the vacancy rate for the Department is 22%. The vacancy rate for the prisons in the LaGrange area, however, is 40%. Several of the prisons work 12-hour shifts to compensate for the staffing shortage. Additional personnel concerns include the high number of security staff (65%) with five (5) years or less experience.

Future personnel needs surround salary compensation, provision of staffing rates for a safe correctional environment, and continued recruitment and retention efforts.

Capital Construction

The Department of Corrections' Six (6) Year Capital Plan addresses Kentucky's aging correctional facility infrastructure and triages based on security and safety considerations.

Department of Corrections' twelve (12) correctional facilities house a maximum operational capacity of just over 12,500 inmates. The Kentucky State Penitentiary, Kentucky's highest security facility, is over 128 years old and four (4) other state facilities are over sixty-five (65) years old.

Department of Corrections has identified major information technology and maintenance requests totaling \$450 million. The biennium priority list is based on building conditions, code compliance, security issues, maintenance and program needs, and environmental concerns. Projects address replacement of kitchen and HVAC equipment, roof and window repair, water/sewer system maintenance, perimeter fence maintenance, and provision of emergency generators.

Department of Corrections received \$6 million in bond funds for FY2018-2020. These funds have been used to repair critical infrastructure necessary to sustain safe and secure operations. Anticipated requests for appropriation would include adequate capacity for the inmate population and maintenance of aging facilities.
