**KENTUCKY INVESTMENT FUND ACT (KIFA)**

**Annual Report**

**July 1, 2022 through June 30, 2023**

The Kentucky Investment Fund Act (KIFA) provides a 40 percent (40%) state tax credit to individuals and corporations that invest in venture capital funds approved by the Kentucky Economic Development Finance Authority (KEDFA) when the approved fund makes a qualified investment in a Kentucky small business. This report provides information regarding funds approved under current legislation.

Legislation: The allocation of tax credits under the KIFA program began in 2003. Under the current law, KEDFA provides a one-time approval for a maximum amount of credits to be authorized for a single fund. Each investment is documented and approved as qualified. Eligible credits are then prorated among the individual investors based on the amount of individual cash contributions.
