Dear Co-Chairman McDaniel & Co-Chairman Petrie:

In the 2022 Regular Session, the General Assembly passed House Bill 1, which later became law. House Bill 1 states that "[t]he Attorney General and the Commissioner of the Kentucky State Police shall . . . develop a report of all cases at the Commonwealth's electronic crimes laboratories and shall submit this report to the Interim Joint Committee on Appropriations and Revenue by December 1, 2022." 22 RS HB 1. My office submits the below report in compliance with 22 RS HB 1.

I. Background

The Kentucky Office of the Attorney General (KYOAG) currently operates a small cyber lab to serve the investigative functions of the Office while also assisting other agencies. The cyber lab is staffed primarily by one forensic examiner. That examiner is certified to conduct computer and mobile forensic examinations. He is housed under the KYOAG's Department of Criminal Investigations and conducts cyber-crime investigations relevant to complaints received by the KYOAG. As part of the Kentucky State Police's Internet Crimes Against Children (ICAC) Task Force, he also receives and responds to cyber tips from the National Center for Missing and Exploited Children. These tips can turn into prolonged investigations with multiple suspects, victims, and crimes.

In 2021, the KYOAG assisted at least 56 unique agencies, including the Kentucky State Police, with forensic examinations of electronic devices (e.g., mobile devices, computers, and removable media). Specifically, the KYOAG assisted with the examinations of more than 312 mobile devices and 91 computers and other removable media. Of the 312 mobile devices examined, 195 involved iPhones and an extraction tool known as Gray Key. Gray Key is a forensic tool that extracts the most data possible from an iPhone, iPad, or iPod Touch. The turnaround time to complete a data extraction is typically seven days. The turnaround time to complete a full forensic examination is typically less than 30 days. This timeframe is considerably faster than most of the KYOAG's counterparts.

II. The Role, Contributions, and Limitations of the KYOAG Cyber Lab

The Kentucky State Police Crime Lab is the primary computer forensic laboratory for the Commonwealth. The KYOAG cyber lab, in addition to serving the investigative functions of the KYOAG, helps with overflow and time-sensitive examinations from the Kentucky State Police's lab.

Since the creation of its Cyber Crime Unit, the KYOAG has invested more than \$200,000 in equipment. This investment does not include the annual license fees for the forensic software. The license fees are in excess of \$50,000 per year. The majority of equipment purchases have been paid using asset forfeiture funds.

The KYOAG cyber lab is used by the KYOAG's Department of Criminal Investigations, Medicaid Fraud Control Unit, and Special Prosecutions Unit, though—as noted above—the KYOAG routinely collaborates with the Kentucky State Police and other agencies on an as-needed basis. For the 10 months of calendar year 2022, the KYOAG cyber lab has assisted 25 local law enforcement agencies, the Kentucky State Police, and two federal agencies with major case investigations.
