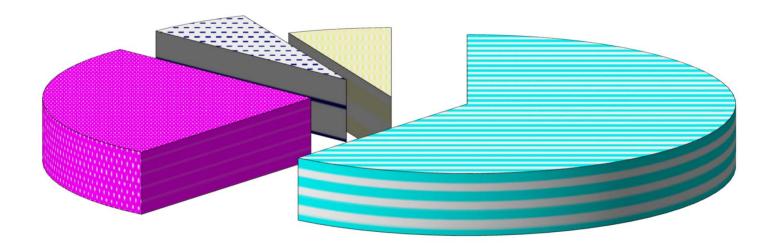

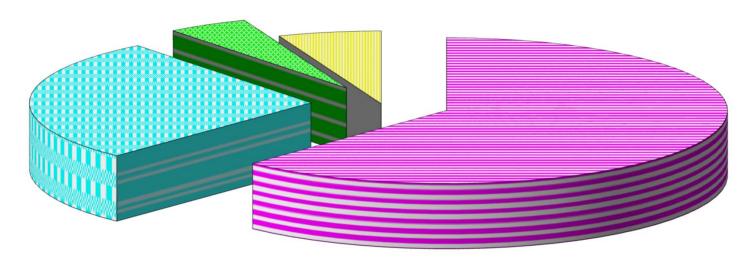

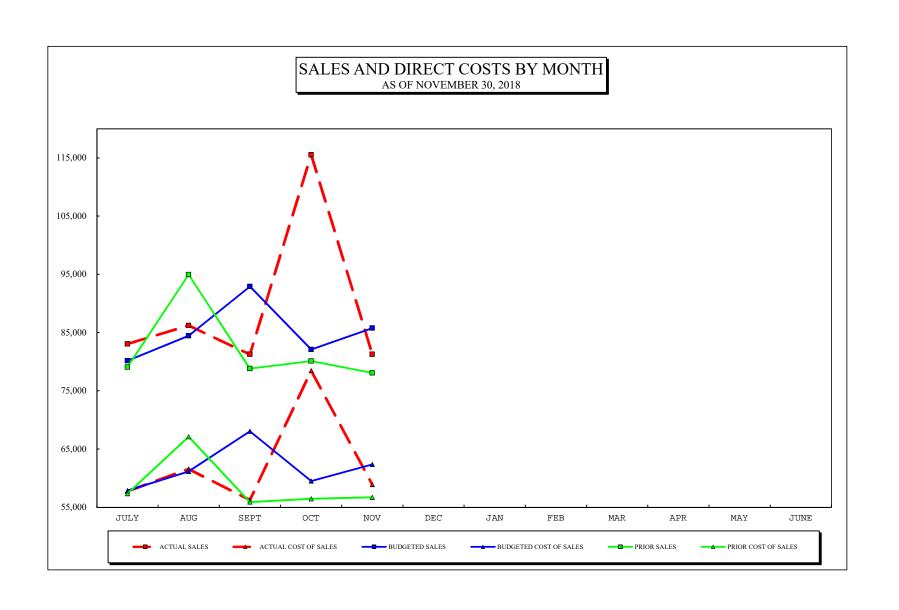

INCOME STATEMENT

Ticket sales for November 2018 were \$81.3 million which is \$2.5 million or 3.1% more than the same month of the prior fiscal year. Sales for the year were \$447.5 million which is \$31.7 million or 7.6% more than in the prior fiscal year. Instant ticket sales were \$1.3 million or 2.8% more than the same month of the prior fiscal year, and \$9.8 million or 4.1% more than the prior fiscal year. Draw game sales were \$580,000 or 1.8% more than the same month of the prior year, and \$19.9 million or 11.7% more than prior fiscal year. iLottery instant play sales were \$571,000 or 86.1% more than the same month of the prior year, and \$1.9 million or 55.3% more than prior fiscal year.

Ticket sales for the month of November were \$4.8 million or 5.6% less than budget. Ticket sales for the fiscal year were \$20.5 million or 4.8% more than budget. Instant ticket sales were \$1.8 million or 3.6% less than budget for the current month, and \$4.9 million or 2.0% more than budget for the fiscal year. Draw game sales were \$3.3 million or 9.4% less than budget for the month, and \$15.1 million or 8.6% more than budget for the fiscal year. iLottery instant play sales were \$294,000 or 31.3% more than budget for the month, and \$472,000 or 9.5% more than budget for the fiscal year.

Prize expenses for November 2018 were 64.2% of total sales, compared to 64.8% in the same month last year and 64.6% budgeted. Combined prize expense for the year was 62.1%, compared to 63.4% last fiscal year and 64.5% budgeted. Instant prize expense for the month was 71.6%, draw game prize expense was 53.0%, and iLottery instant play prize expense was 71.2%. Instant prize expense for the fiscal year was 69.3%, draw game prize expense was 52.3%, and iLottery instant play prize expense was 70.8%.

Operating costs were \$2.5 million for November, compared to \$2.6 million budgeted and \$2.2 million for the same month last year. These costs included advertising and promotions of \$849,000, salaries & benefits of \$1.2 million, contracted and professional services of \$251,000, depreciation expense of \$103,000, and other general and administrative costs of \$177,000. Operating costs for the year were \$12.3 million, compared to \$14.1 million budgeted and \$11.7 million prior fiscal year.

Income before transfer of dividends for the current month was \$19.9 million, compared to \$19.2 million for the same month in the prior year and \$20.8 million budgeted. Income before transfer of dividends for the fiscal year was \$122.3 million, compared to \$106.0 million in the prior year and \$102.5 million budgeted.

Dividends of \$21.5 million were transferred to the Commonwealth in November for a total of \$98.5 million for the fiscal year. Additional dividends of \$347,000 were accrued in November for transfer to the KEES Reserve for a total of \$4.6 million for the fiscal year. Transfers to the KEES Reserve will be made quarterly during the fiscal year. All dividends were 26.9% of sales for the month. All dividends were 23.1% of sales for the fiscal year compared to 24.3% of sales in the prior year and 24.0% budgeted.

BALANCE SHEET

Cash balance increased to \$34.8 million, which included \$2.9 million restricted for annuity prize payments. Total investments held to pay grand prizes decreased to \$9.9 million. Accounts Receivable decreased to \$28.5 million. Total assets decreased to \$85.5 million.
