## MARCH AT A GLANCE

- March sales totaled a record \$197.8 million, which is \$28.9 million or 17.1% more than last March.
- Scratch-off sales were \$88.1 million in March, which is \$2.2 million or 2.5% less than last year at this time.
- Draw game sales totaled \$50.0 million, which is \$10.9 million or 28% more than last March.
  Increased sales were fueled by dueling
  Powerball and Mega Millions jackpots that both climbed towards \$1 billion in March.
- March's iLottery Instant Play sales were \$59.7 million, which is \$20.2 million or 51.1% more than last year's sales at this time.


