OVERVIEW

The Kentucky General Assembly created the Office Claims and Appeals (OCA) in 2021 to administer the Crime Victims Compensation Board (CVCB), the Board of Claims (BOC), and the Board of Tax Appeals (BTA).

KRS 49.020(1)(b) grants the Board of Tax Appeals the power and authority to hear and determine appeals from final rulings, orders, and determinations of any revenue and taxation agency. The Board consists of three members appointed by the Governor, subject to Senate confirmation. Two board members must be attorneys with the qualifications for Circuit Judge. One board member must have a background in taxation.

KRS 49.020(5) grants the Board of Claims the power and authority to investigate, hear proof, and compensate persons for damages sustained to either person or property as a proximate result of negligence on the part of the Commonwealth, any of its cabinets, departments, bureaus, or agencies, or any of its officers, agents, or employees while acting within the scope of their employment by the Commonwealth or any of its cabinets, departments, bureaus, or agencies. The Board consists of three members appointed by the Governor, subject to Senate confirmation. Two members of the Board shall be attorneys with the qualifications required for candidates for Circuit Judge and have a background and working knowledge in Kentucky tort law. One member shall have a background in business.

KRS 49.020(3) grants the Crime Victims Compensation Board the power and authority to hear and determine all matters relating to a claim by a crime victim or a person authorized by law to act on behalf of a crime victim for compensation. Victims or authorized persons may submit claims for a wide variety of expense types incurred as a result of a crime. The Board also hears and adjudicates claims under the Sexual Assault Examination Program ("SAEP") submitted by medical providers for reimbursement of expenses incurred related to sexual assault forensic examinations. The Board consists of three members appointed by the Governor and subject to Senate confirmation, not all of whom shall be engaged in the same occupation or profession. Two of the Board members shall be a victim as defined in KRS 421.500(1), the parent, spouse, sibling, or child of a victim as defined in KRS 421.500(1), whether or not the victim is deceased, or a victim advocate as defined in KRS 421.570(1). The other Board member shall be an attorney licensed to practice law in the state with two years of experience.

Each board is separately authorized to promulgate suitable administrative regulations to carry out the provisions and purposes of the board's statutory authority; issue subpoenas and discovery orders, and to petition a court of competent jurisdiction for any order necessary to carry out the board's powers and duties; take or cause to be taken affidavits or depositions within or without the state; administer or cause to be administered oaths; except for the power to issue final decisions

on the merits of a claim or appeal, to delegate any of its power or authority to the Office of Claims and Appeals; and publicize widely the functions and purposes of the board.

KRS 49.010(3)(d) requires OCA's Executive Director to prepare annual reports of the office and boards' activities. Further, KRS 49.300(8) requires the Executive Director to make an annual report, by January 1 of each year, of the Crime Victims Compensation Board's activities for the preceding fiscal year to the Office of the State Budget Director and the Interim Joint Committee on Appropriations and Revenue. Each report shall set forth a complete operating and financial statement covering the CVCB's operations during the year.

OCA's Executive Director submits this annual report in accordance with KRS 49.010(3)(d) and KRS 49.300(8). The below sections summarize OCA and its boards' activities during Fiscal Year (FY) 2024.

Training, Outreach, and Updates

KRS 49.300(7) requires CVCB to publicize widely the availability of reparations and information regarding the claims therefor. In addition to publishing information and resources on its website and widely distributing an informational brochure and other materials at conferences and events, CVCB conducts periodic trainings to detail the available reparations under its programs, the application and claims process, and the operations of the CVCB.

In FY24, CVCB conducted 11 trainings. The attendees for those trainings totaled 269. Attendees worked for or represented 97 diverse organizations, agencies, and nonprofits.

During FY24, OCA applied for and received a grant through the Victims of Crime Act (VOCA) Assistance program to hire a victim advocate. OCA hired the victim advocate in FY25, and he has made great strides in assisting victims with filing and perfecting their Crime Victims



Compensation claims, as well as building a network of other victim service organizations across the Commonwealth.

Pursuant to Senate Bill (SB) 378 passed in the Kentucky General Assembly's 2022 Regular Session, which amended KRS 49.010 and 49.020, staff and members of the Crime Victims Compensation Board are required to receive six (6) hours of trauma-informed training within thirty (30) days of hire or appointment, then three (3) hours of training each year thereafter. In compliance with these new provisions, OCA planned, and members and staff of the CVCB attended, a trauma-informed training in August 2023 conducted by the management and staff of the Cabinet for Health and Family Service's Department for Behavioral Health Developmental and Intellectual Disabilities. The training was engaging and effective, and empowered staff and board members to better serve the victims and survivors with whom they interact. The Board has scheduled its 2024 training for December 10, 2024.

In FY24, the Crime Victims Compensation Program received the largest number of annual claims in its history. Total claims received for the program equaled 438. This constitutes a 21% increase from the total of 361 claims received in FY23.

In the 2024 Regular Session, the Kentucky General Assembly passed SB 319, introduced and sponsored by Senator Denise Harper Angel, which significantly expanded the Crime Victim Compensation and Sexual Assault Examination programs.

Regarding Crime Victims Compensation, SB 319 broadened the scope of individuals who are eligible to receive awards, including when they are a victim of motor vehicle crimes; increased monetary award caps; eliminated the statute of limitations for filing claims and the requirement to report crimes to law enforcement within a short timeframe; added deadlines for claim processing to shorten the time victims must wait to receive a decision on their claim; added provisions to increase transparency into claim status and the Board's decision making; and added new award categories, including costs for relocation, temporary housing, tattoo removal for victims of human trafficking, crime scene cleanup, replacement of items seized by law enforcement, replacement or repair of windows and locks, rehabilitative and wellness practices, and court proceedings related to the crime.

Regarding the Sexual Assault Examination Program, SB 319 expanded the program to require reimbursement for not only sexual assault examinations and basic related treatment, but also for prophylactic medical treatment, strangulation assessments, and other tests and services related to the incident or exam which occur on the same date as the original exam.
