Kentucky Supreme Court Case Update

Chief Justice Laurance B. VanMeter

Laurance B. VanMeter is the sixth Chief Justice of the Commonwealth; the third Justice to have served at all four levels of Kentucky's unified court system and the only one of those to have served as Chief Justice. His degrees are from Vanderbilt University (B.S.), University of Kentucky College of Law (J.D.) and Duke University School of Law (LL.M).

Description – Chief Justice VanMeter will discuss recent Kentucky Supreme Court cases and provide written summaries and descriptions of the cases.

Description – The presentation and written materials will focus on the 2022 Amendments to the Uniform Commercial Code (UCC), which are the first update to the entire UCC that the Uniform Law Commission has offered since Kentucky adopted the UCC in 1958. The session will focus on the changes to the Articles to facilitate commerce in the digital age and the new Article 12 which provides a UCC framework, and the certainty of outcomes that come with that, for digital assets. These changes have an effective date of January 1, 2025.

Description – The presentation will provide an overview of the KRS Chapter 13A requirements for administrative regulations, with a special emphasis on drafting and formatting rules. Other topics covered will include types of regulations, emergency regulations, incorporation by reference, required forms, statements of consideration, and filing regulations with the Legislative Research Commission. Written materials will include a copy of the PowerPoint, a chart of regulation filing and effective dates, a regulation filing checklist, and a regulation writer quick reference sheet.

An Introduction to the Legislative Research Commission and the Legislative Process
