### BRIEF HISTORY OF KENTUCKY MANAGED CARE ORGANIZATIONS



- <u>1986</u>: The first managed care program, the Kentucky Patient Access and Care (KenPAC) Program primary care case management program (PCCM), was introduced.
- <u>1997</u>: Kentucky Health Partnership, a comprehensive risk-based managed care program was implemented.
- <u>2011</u>: The KenPAC (PCCM) program was terminated and Medicaid received approval to expand managed care statewide to cover beneficiaries in regions, not served by Kentucky Health Partnership.
- <u>2013</u>: The state began awarding contracts to additional MCOs to manage care for beneficiaries in the region served by the Kentucky Health Partnership.
- <u>2014</u>: Kentucky expanded Medicaid Managed Care to the expansion population through an Alternative Benefit Plan (ABP).

- Managed care represents approximately 90% of Medicaid's total enrollment
- The remaining 10% of the population (FFS) represents approximately 28.5% of Medicaid's spending



#### **FEDERAL FUNDING**



- Federal match (FMAP) changes every October for the traditional population and is based on a rolling three year average of a state's per capita income.
  - Traditional FMAP is usually around a 70/30 split
    - Effective October 1, 2019, the traditional FMAP will increase from 71.67% to 71.82% requiring less state matching funds.
- FMAP for the ACA Expansion population will change from 93% to 90% on January 1, 2020 at which time the State Funding level will increase from 7% to 10% for all benefit expenditures related to Expansion, requiring more state matching funds.
- FMAP changes every October for the CHIP population
  - <u>CHIP is usually around a 80/20 split</u>
    - Currently Kentucky receives an additional 23 basis points (not to exceed a total of 100% FMAP) for the CHIP population as part of the Affordable Care Act.
    - Effective October 1, 2019, the additional basis points will be phased out with states only receiving half (11.5 basis points) for FFY20 and completely phased out in FFY21
    - CHIP FMAP will decrease from 100% to 91.77% on October 1, 2019 and then decrease to 80.62% on October 1, 2020



### **BRIEF HISTORY OF KCHIP**



- The Children's Health Insurance Program (CHIP) was signed into law in 1997
- It provides federal matching funds to states to provide health coverage to children in families with incomes too high to qualify for Medicaid, but who cannot afford private coverage
- The Kentucky Children's Health Insurance Program (KCHIP) is free or low-cost health insurance for uninsured children, younger than 19, who live in families with income at or less than 218 percent of the federal poverty level.



#### Covered services include:

- Doctor visits
- •Dental care
- Hospitalization
- •Outpatient hospital services
- Psychiatrists

#### Children can also get:

- Glasses
- Immunizations
- •Well-child checkups
- Physical therapy
- Speech therapy
- And many other services

- Laboratory tests and X-rays
- Vision exams
- Hearing services
- •Mental health services
- Prescription medicines
