Fiscal Year 2023 Spending To date \$273 million has been expended for Necessary Government Expenses.

This is the largest amount in history.

The Eastern Kentucky Flooding is \$260 million of this amount.

### Budget of the Commonwealth

- Appropriates \$4.5 million annually for Necessary Government Expenses in the enacted budget.
- Allows for additional expenditures for Necessary
  Government Expenses for Governor declared emergencies,
  Governor's call of the Kentucky National Guard, and to
  match federal aid for presidentially declared disasters or
  emergencies.
- The funds for additional Necessary Government Expenditures come from the Budget Reserve Trust Fund.

### **Governor and Impacted Communities Issue State of Emergency Orders**

Significant events trigger issuance of state and local state of emergency orders as provided in KRS 39A.100, which

- Directs state agencies to respond to the emergency or disaster in the manner directed
- Provides for the purchase of goods and services essential for the protection of public health and safety or to maintain or restore essential public services



### Impacted Communities Submit Resource Requests to the SEOC

SEOC maintains constant contact with impacted areas County Emergency Management Directors provide situational awareness by:

- Phone contact with SEOC and/or KYEM Area Managers
- Submitting information via WebEOC software platform

Resources often requested to save lives and protect property include:

- Shelter, Food, Water

- Incident Management Teams

- Generators

- Search and Rescue Teams

- Debris Removal Teams

- Security Forces



### SEOC Assigns Requests to Appropriate Agencies for Fulfillment

Support agencies are deployed to provide needed assistance such as:

- Division of Forestry debris cut and toss teams
- State Police security protection for impacted areas
- Transportation Cabinet delivery of food and water, clearing of roads
- Energy and Environment coordination of power restoration

When State resources are not sufficient, the SEOC will ask for support from:

- Non-impacted counties
- Other states, using the Emergency Management Compact Agreement
- Federal Emergency Management Agency



### **KYEM, DMA, and FAC Procure Goods and Services for Delivery to Impacted Areas**

Procurement specialists from KY Emergency Management, Dept. of Military Affairs, and the Finance Cabinet manage all procurement from the SEOC.

All costs are charged to a disaster-specific accounting code.

#### Procurement considerations include:

- Compliance with state and federal requirements
- Use of state Master Agreements
- Availability of items time is crucial
- Costs must be reasonable under exigent circumstances
- Careful documenting of procurement process



### **Using NGE Funds, KYEM Reimburses Deployed Agencies and Pays Vendors**

Agencies/entities deployed by SEOC request reimbursement of response expenses.

- Salaries
- Equipment
- Travel lodging, per diems

Vendors invoice KYEM for response purchases

- Food, water
- Equipment, fuel
- Sheltering
- Temporary facilities office trailers, responder housing



### **KYEM Requests that FEMA Reimburse Emergency Response Costs of SEOC**

A formal request is made of FEMA to provide federal assistance for cost of SEOC's emergency actions.

#### Category A – Debris Removal

- Cut and toss teams
- Hauling
- Disposal

#### **Category B – Emergency Protective Measures**

- Operation of SEOC
- Cost of deployed agencies
- Supplies, equipment
- Sheltering, feeding



### **FEMA Prepares, Approves, and Obligates SEOC Projects**

This process may take a few months or well over a year.

KYEM, as the applicant, provides FEMA with detailed documentation for all costs associated with SEOC response activities.

FEMA groups similar expenses and purposes into individual projects.

Projects undergo multiple layers of review by FEMA.

Projects receiving final approval are obligated.



### **KYEM Transfers FEMA Awards** to NGE Account

Typically, FEMA provides 75% of actual, approved costs.

The tornado event provides 100% reimbursement for a 30-day period and 90% for the remainder.

For the flood declaration there is a 30-day period for reimbursement at 100% for emergency response costs. The remainder is at 75% federal/25% state.

When a KYEM SEOC project is obligated, a JV2T transaction is prepared which moves the FEMA awarded funds back to the General Fund account.
