Optometry Program Overview

- Optometry program was established in 1974 as an Optometry Contract Spaces program through the Southern Regional Education Board (SREB)
 - Allowed Kentucky residents to enroll in participating institutions while paying tuition at a rate equivalent to in-state students
 - Set number of spaces reserved for Kentucky students at each institution, with the campuses selecting recipients
 - State paid a contract fee to the institutions to cover the difference in tuition rate (in/out state)
 - Four participating institutions
 - Indiana University School of Optometry
 - Southern College of Optometry
 - Univ. of AL Birmingham College of Optometry
 - Kentucky College of Optometry (est. 2016)



Optometry Study

HB 200 in 2018 established an Optometry Contract Spaces (OCS) work group to study the effects of establishing a forgivable Optometry loan program for OCS students and the projected return of Optometry graduates to practice in Kentucky

Workgroup recommendations

- Imposing a service requirement to the Optometry CS program was not required based on the high percentage of recipients who are licensed to practice in Kentucky and the pipeline of optometrists from the Kentucky College of Optometry
- > Change in program structure was needed to ensure the program's financial sustainability
- Limit funding to the existing OCS out-of-state institutions and the Kentucky College of Optometry
- Change to a scholarship model with parameters established by the General Assembly, administration by KHEAA, and awardees selected by a committee of optometry professionals and educators
- Recognize the role of the Kentucky College of Optometry by dedicating at least one-third (1/3) of the scholarship funding to students attending the institution



Optometry Scholarship Program

- Optometry Scholarship program established during 2020 Regular Session (SB 134), now codified as KRS 164.7870
- KHEAA began program administration with FY 2021
- Optometry Contract Spaces recipients were grandfathered into the scholarship program with scholarship amount fixed at FY 2021 OCS rate
- First scholarship recipients began enrollment fall 2021; anticipated graduation spring 2025
- Per statutory language, at least one-third (1/3) of scholarship appropriation is awarded to students attending KY College of Optometry
- Committee selects scholarship awardees
- Funds follow students to one of the participating institutions



Veterinary Contract Spaces Overview

- Kentucky's Veterinary Contract Spaces (VCS) participation began in 1951
- VCS supported solely through biennial budget until 2020 Regular Session and passage of HB 214; now codified as KRS 164.790
 - KHEAA began program administration in FY 2021; prior administration by KY Council on Postsecondary Education
- > Funding currently supports 164 contract seats at two participating institutions
 - Auburn University College of Veterinary Medicine 152 spaces each year (38 per class)
 - Tuskegee University College of Veterinary Medicine 12 spaces each year (3 per class)
- KHEAA verifies Kentucky residency of students; institutions select awardees
- Southern Region Education Board (SREB) sets contract rate for each year



Veterinary Contract Spaces Study

HB 200 in 2018 established a Veterinary Contract Spaces work group to study the effects of establishing a forgivable loan program for VCS students and the projected return of large animal Veterinary graduates to practice in Kentucky

Workgroup recommendations

- Imposing a service requirement through a forgivable loan to the VCS program is not needed based on the percentage of former VCS students licensed to practice in KY
- Kentucky should continue to purchase spaces from Auburn University and Tuskegee University given the long-standing and positive relationship with those institutions, and not transition to a scholarship model or introduce additional institutions to the program
- In a flat or decreased funding environment, maintaining the 164 contract spaces is a top priority
- Explore strategies and programs to provide lower cost loans for veterinary students, and pursue supplemental funding for the program if General Fund support is not sufficient to cover program costs



KY Rural Veterinary Medicine Student Loan Repayment

- Established during 2024 legislative session (HB 553); now codified as KRS 164.7895
- Provides student loan repayment benefits for veterinarians practicing large animal medicine in underserved rural or veterinary shortage areas in Kentucky
- Awardees must provide one year of service as livestock practitioner in order to receive loan repayment benefits; limited to 5 consecutive years of participation
 - Incremental amount starting at \$12,500 in year 1 and increasing to \$22,500 in year 5
 - Total student loan repayment not to exceed \$87,500 per recipient
- Competitive selection process
 - Selection committee comprised of KY Commissioner of Agriculture (or designee), KY Board of Veterinary Examiners, KY Veterinary Medical Assn., KY Farm Bureau, and KY Cattlemen's Assn.
- KHEAA is administering agency; coordinates application and selection process, and disburses student loan repayment funds to recipient's lender following annual verification of service
- Currently funded at \$1.1 million
