State Agency Children


School Age Children and Youth who are in the custody or care of the Commonwealth and being served in a program that is operated or contracted with the Cabinet for Health and Family Services or the Department of Juvenile Justice. (KRS 158.135)

Programs Include:

- Residential Treatment Programs
- Group Homes
- Hospital Based Programs
- Detention Centers
- Youth Development Centers
- Day Treatment Programs
- Community Based Shelters




State Agency Children are Educated in 72 Programs Operated or Contracted with the Commonwealth




State Agency Children Demographics

Academic Preparedness of State Agency Children




All State Agency Children are academically assessed upon enrollment in an education program. State requirements note a 30-day assessment window, but KY programs assess within 10 days. Eighty-two (82) percent of State Agency Children test below grade level in math upon enrollment.



Seventy-nine (79) percent of State Agency Children test below grade level in reading upon enrollment. Most State Agency Children are more than two grade levels behind their peers upon enrollment.

How are We Solving this Issue: Enhanced Educational Opportunities

How are We Solving this Issue: Enhanced Educational Opportunities



Individualized instruction with fully certified educators. Each student has an individualized plan of instruction and receives both direct instruction and technology assisted support. Over sixty percent (60%) of educators in state agency programs are certified in special education.



All programs are monitored annually by multiple agencies to ensure State Agency Children are receiving the education they need and deserve. Local school districts offer the full curriculum, credit recovery, high school equivalency programs, and vocational training.



Return on Investment

Students enrolled in a state agency program at a local school district for 90 days show significant academic growth:

- Nearly 60% of state agency children grow up to a full grade level or more in math in 90 days.
- Nearly 55% of state agency children grow up to a full grade level in reading in 90 days.

Kentucky Foster Youth have a 40% higher high school graduation rate than the national average for foster youth! (Kentucky School Report Card)





Financial Support

- Nearly 8,500 students per year enter state agency programs, nearly all are behind their peers academically upon entry.
- Supplemental educational services that are necessary to close the achievement gap for these students are expensive.
 - State Agency Children are disproportionally identified with special education needs, requiring highly certified teachers.
 - Extended school calendars require significant investment of resources.
- State Agency Children's Funds allocated by the General Assembly are expended only to support the education of state agency children. Districts do not have discretion to redistribute these funds for other purposes. All funds are tracked down to the local program level.
- Typically, local districts provide supplemental funding for these programs, in addition to the line item.

- Our budget request is for \$18,000,000 during each fiscal year in the upcoming biennium to meet the educational needs of our Commonwealth's most vulnerable student population.
