The Secretary of the Finance and Administration Cabinet has approved a capital project for the Department of Military Affairs to construct the Joint Force Headquarters Project at the Boone National Guard Center in Frankfort in the amount of \$17,623,440. The Project is funded with \$17,406,100 federal funds and \$217,340 agency restricted funds.

This project will construct a National Guard Readiness Center that will be approximately 63,726 sq. ft. Facilities constructed in this project will be designed for a 50-year useful life. The Readiness Center will comply with Unified Facility Criteria and Antiterrorism and Force Protection Standards.

Authorization is requested, pursuant to KRS 45.760, for approval of a new Capital Construction project to construct the Joint Forces Headquarters stationed on the Boone National Guard Center in Frankfort, Ky. This appropriation request for \$17,406,100 is 100% federally funded from the DoD Military Construction Cooperative Agreement with the exception of \$217,340 which is funded from Military Affairs Restricted funds.

This project will construct a 63,726-SQFT National Guard Readiness Center. The facility interior layout will support staff section functionalities and requirements identified in this project's programming charrette. The facility will possess an emergency standby generator with automatic transfer switch, construction also includes walks, curbing & drainage, and site improvements necessary. This project will also maximize existing privately-owned vehicle parking, military vehicle parking, and utilities on site. Modern, efficient energy features will be incorporated into the design to include photovoltaic, cohesive natural and energy efficient lighting systems, digital controls, encapsulation of the building envelope, and use of a modern heat pump system specially designed for its efficiency and practical maintenance. Facilities constructed in this project will be designed for a 50-year useful life. Additionally, the Readiness Center will comply with Unified Facility Criteria and Antiterrorism and Force Protection Standards, access for disabled citizenry, and other applicable building codes.

Capital Project Scope Increase-Restricted Funds

The Secretary of the Finance and Administration Cabinet is reporting an appropriation increase in the amount of \$1,000,000 for the Fire Commission's National Responder Preparedness Center Parking Lot project. The project is funded from the Fire Commission's Restricted Funds.

This project was originally authorized in the 2018-2020 biennial appropriations act in the amount of \$2,000,000. Phase A design indicated significant soil bearing issues that will require extensive site remediation prior to construction, requiring an increase in the project's scope of \$1,000,000. This action will bring the project's total authorized scope to \$3,000,000.

Dear Secretary Johnson:

The Kentucky Community and Technical College System (KCTCS) respectfully requests approval, pursuant to KRS 164A.575.(15), of a capital construction project scope increase for \$1,000,000 for the Fire Commission National Responder Preparedness Center Parking Lot. This project received authorization in the 2018-2020 budget for \$2,000,000. KCTCS received approval from the KCTCS' Board of Regents on December 6, 2019.

This project will develop a driving course around the current training structure. This will enable the Kentucky Fire Commission to deliver state of the art training to Commonwealth's firefighters, industrial customers and military troops. As part of Phase A design, a geotechnical exploration was performed on the site. This study indicates poor soil bearing properties thus requiring extensive remediation to the site.

Due to this study and to be able to move forward with bidding this project, KCTCS is requesting approval to increase the scope of the project by \$1,000,000, which will be funded from agency funds. The design and construction of the project is being pursued through the Finance and Administration Cabinet.

The Tourism Arts and Heritage Cabinet, On behalf of the Kentucky Department of Parks, is requesting to report a capital project entitled BR-Lodge-Exterior Repairs & Reroof identified as fund number C95X. The total estimated cost of the project is \$1,950,000.00. The project will be partially funded from the Maintenance Pool bond fund, pursuant to the 2018-2020 biennial budget bill and the Lodge Roof Replacements and Repairs Pool, pursuant to House Bill 268.

The project will consist of exterior repair and reroofing of the Lodge at Barren River State Resort Park. The work will include repairs and replacement of the aging roof, exterior siding replacement, front canopy replacement, limited window replacement, repainting and other miscellaneous items. The purpose of this project is to stop further building structure degradation due to weather infiltration. The Kentucky Department of Parks has been working with the Finance and Administration Cabinet's Division of Engineering and Contract Administration on the scope and design of the repairs. The project bidding is complete and we are awaiting contract establishment.
