Pursuant to KRS 45.760(7), the Secretary of the Finance and Administration Cabinet has approved an appropriation increase in the amount of \$349,000 for a total scope amount of \$1,999,000 for the Department of Military Affairs Wendell H. Ford Regional Training Center Fire Station Addition Project in Greenville. The project is 100% federally funded.

The project was originally reported in June 2020 in the amount of \$1,650,000

This increase is for award of construction contract and contingencies.

The building will be a 6,000 square foot multiuse apparatus storage, billeting, and office space structure. An increase in the square footage requirements is needed due to the modernization of their fleets and an increase in the number of apparatus and firemen assigned for the WHFRTC.
