Dear Secretary Johnson:

The Education and Workforce Development Cabinet respectfully requests your approval of a capital project for the Office of Vocational Rehabilitation to fund the purchase and implementation of a new case management system.

In the 2020-2022 biennial budget submission, this project was requested and identified as needing bonded funds, but due to funding limitations, the project did not receive approval. However, after further review and a federal grant award increase from the U.S. Department of Education's Rehabilitation Services Administration, the entire project estimated at \$4,620,000, may now be funded using existing federal funds.

Authorized by the US Rehabilitation Act of 1973, the Office of Vocational Rehabilitation serves Kentuckians with disabilities by providing them an opportunity to pursue meaningful employment and fostering independence. The current case management system in use by the organization was implemented in 2008, and is primarily an in-house, custom-developed system with outdated and limited capabilities; hindering the agency's ability to integrate enhancements and vital updates.

To ensure the new system is purchased, developed, and implemented during the allowed project period for the federal grant award, your immediate approval is imperative.

The Secretary of Finance has approved a 100% federally funded project for Kentucky State University to renovate Hunter Hall on the campus of Kentucky State University in the amount of \$2,300,000. This project was approved by the Board of Regents on September 6, 2018 and by the Council on Postsecondary Education on September 21, 2018. It will be funded from a USDA grant. The funds will be used for a renovation project designed to transition Hunter Hall from a residence hall to an office, classroom, and laboratory building to be occupied by the KSU Land Grant Program.

Dear Secretary Johnson:

Pursuant to KRS 48.760(7), Kentucky State University (KSU) is requesting your approval to proceed with the federally funded Hunter Hall construction project. The Hunter Hall construction project has been awarded \$2,300,000.00 through the USDA funded "Agricultural Experiential Learning Center" proposal. The award letter is attached for your review and as documentation and the funding for the project is 100% sourced in federal funds.

In processing this federal award for Hunter Hall construction, KSU's Office of Finance and Administration, which includes the KSU Grants Accountant, the Controller and the Chief Financial Officer (CFO), along with the budget manager in the College of Agriculture, Community, and the Sciences, uses the following accounting system:

KSU's Land Grant budget manager submits the invoices to the USDA for approval each time an invoice is received. Copies of invoices are submitted to the USDA for approval which triggers the release of funds for institutional use and financial draw down. The turnaround time for the approval of invoices by the USDA is approximately twenty-one (21) days from submission of the approval request.

The General Accounting office follows the internal process steps as presented below:

- General Accounting reconciles and receives the Capital Projects reports from the state and sends copies of invoices for approval to the grant project director before charging to federal awards and are then sent to KSU Accounting.
- Expenses are then posted and funds are drawn down from USDA-NIFA.
- Once the University receives the funds, a letter is sent from the Controller/VP Finance to transfer funds to reimburse the state for those projects.

Grant funds are drawn down at least once per month, sometimes more depending on the amount of expenses.

Pursuant to KRS 45.760 the Kentucky Department of Veterans Affairs (KDVA) requests an appropriation and allotment increase in the amount of \$240,000 for the Improve/Expand Pavement and Parking Areas project.

The line item approved in HB352 was \$1,600,000. The increase requested, per the Division of Engineering and Contract Administration (DECA) is \$240,000, which would bring the project to a new total of \$1,840,000.

Poor subbase requires additional excavation and stone fill to provide adequate base for traffic/deliveries to the Thomson-Hood Veterans Center. Dear Secretary Johnson,

The Tourism Arts and Heritage Cabinet, on behalf of the Kentucky Department of Parks, is requesting to report a capital project entitled FB – Parkwide – Flood Reconstruction identified as fund number CA1J. The project has been established, is under construction, and will be funded by a combination of restricted funds as a result of insurance/FEMA reimbursements. Project scope increases will result in costs exceeding \$1,000,000. The current estimated cost of the project is \$1,300,000.

The project will include site and building restoration and reconstruction efforts resulting from the parkwide flood event. Effected buildings and areas include the Recreation Hall, campground area, campground shelters, campground bathhouses, maintenance shop, pole barn, playground areas, and the Beach House. Loss of equipment and site furnishings include tractors, mowers, park benches, fire rings, and various small equipment. Major electrical, plumbing and mechanical restoration will be required throughout the park.

Kentucky Department of Parks working in conjunction with the Division of Engineering and Contract Administration is coordinating the project with The Division of State Risk and Insurance Services and FM Global to assign project scope and document funding coverage. Funding is expected to be fully reimbursed by Insurance along with a future request for FEMA related weather event coverage.
