Dear Secretary Johnson,

The Cabinet for Health and Family Services (CHFS), on behalf of the Department for Public Health (DPH), requests to increase the appropriation for capital IT project C93A DPH - Scan and Image Historical Records by \$750,000 to total \$5,750,000.

The \$5 million appropriation established with Agency Restricted Funds was based on estimated costs. The actual cost to scan and store Office of Vital Statistics records, which is based on the creation of a statement of work and negotiated bid with the Commonwealth's vendor Iron Mountain, exceeds the established budget. The increase in cost is due primarily to an unanticipated increase in General Services Administration pricing for document scanning along with CHFS staff processing the Meta Data into a Document Management System and the development of a web application for DPH staff to access the scanned images. An additional \$750,000 is needed to complete this project with the necessary data security measures in place.

Dear Secretary Johnson,

The Cabinet for Health and Family Services (CHFS), on behalf of the Department for Public Health (DPH) and the Division of Laboratory Services (DLS), requests approval to establish a capital project per KRS 45.760(5), KRS 214.020, and KAR 2:020.

DPH requests a Sole Source competitive bidding exemption to purchase from BRUCKER, MALDI Biotyper® (MBT) Sirius CA System and 1-year Service Agreement. The MALDI Biotyper (MBT) is a microbial identification system based on MALDI-TOF mass spectrometry, allowing unbiased identification of microorganisms within a few minutes down to the species level. DLS will utilize the FAP 111-10-00-03 and FAP 111-10-00-05 to create this Purchase Order. Continuous expansion of the reference library ensures that a broad range of microorganisms can be identified easily.

This platform will also be used to run a new assay for detection of C. botulinum toxin, which will provide significantly faster turnaround time and increase savings of valuable scientist time. Without this equipment, DLS will be unable to continue to upgrade its methods of testing thru modernized technologies. The cost is of the MALDI Biotyper Sirius CA System will be \$226,530.00 including shipping; the Database-CD BTyp2.0-Sec Library will be \$7,173.00; and the LabScape Complete MALDI Biotyper Maintenance Agreement will be \$20,070.00. The total cost for this purchase is \$253,773.00. This will be funded with 100% Federal Funds.
