The Secretary of the Finance and Administration Cabinet is reporting a project greater than \$1,000,000 pursuant to 2022 Regular session, House Bill 1, Part II, (4). The project in the amount of \$1,212,000 for the Department of Corrections Roofing Design East project is funded with 2022-2024 Maintenance Pool General Funds.

This project covers the design and consultant studies for the roofs of three correctional complexes: Blackburn Correctional Complex (BCC), Northpoint Training Center (NTC), and Little Sandy Correctional Complex (LSCC). Both BCC and NTC roofs are over 30 plus years old and aged past their life cycle and warranty; with LSCC quickly approaching its life-cycle and warranty. All three correctional complex roofs are showing tears, cracks, and creating leaking issues; further stressing institutional maintenance staff, which are not equipped to handle repairs of this scale and are not capable of replacement. The studies and design produced will provide specifications and cost estimates for roof replacements for the three facilities and have a new 20-year warranty.

Appropriations for Projects Not Line-Itemized

CAQK- Department of Corrections (DOC)- Roofing Design EAST

The Department of Corrections (DOC) would like to report project CAQK DOC Roofing Design EAST, in the amount of \$1,212,000.00 to the Capital Projects and Bond Oversight Committee pursuant to 2022 Regular Session, House Bill 1, Part II (4) Appropriations for Project Not Line Itemized for Approval. This project is funded in its entirety with General Funds from CAL5-Maintenance Pool 2022-2024.

CAQK DOC Roofing Design EAST covers the design and consultant studies for the roofs of three (3) correctional complexes: Blackburn Correctional Complex (BCC), Northpoint Training Center (NTC), and Little Sandy Correctional Complex (LSCC). Both BCC and NTC roofs are over 30 + years old and aged past their life-cycle and warranty; with LSCC not far behind and quickly approaching its life-cycle and warranty. All three correctional complex roofs are showing tears, cracks and creating leaking issues; further stressing institutional maintenance staff, which are not equipped to handle repairs of this scale and are not capable of replacement.

The studies and design produced from DOC-Roofing Design East will provide specifications and cost estimates for roof replacements projects at BCC, NTC, and LSCC. All roof replacements developed from the designs produced in DOC-Roofing Design East will have a new 20-year warranty, deferring maintenance for many years.



The Kentucky Community and Technical College System (KCTCS) respectfully requests the reporting to the Capital Projects and Bond Oversight Committee of a capital project in excess of \$1,000,000 from the Asset Preservation Pool within the 2022-2024 enacted budget. The project is for Ashland Community and Technical College for roof replacements on two buildings: the Main Campus Goodpaster building and the Technology Drive Campus building. The total cost of the project is \$1,598,000. \$1,389,621 is being funded from the asset preservation bond pool and \$208,379 is being funded from KCTCS restricted funds as their required 15% match. The reporting of this project to the Committee is pursuant to Part II, I., (1) of the 2022-2024 Commonwealth Budget.
