Dear Senator Girdler, Representative Frazier Gordon and Members of the Capital Projects and Bond Oversight Committee:

Pursuant to KRS §56.823 this is to report a new lease and an amendment to a current lease. Both leases exceed \$200,000 annually and are authorized in the Executive Branch Budget Bill, House Bill 1. The University, after careful consideration, determined that these leases are in the best interests of UK and the Commonwealth of Kentucky.

The new lease is for 11,500 square feet of clinical space located at Eastern State Hospital, 1350 Bull Lea Road, Fayette County, Kentucky. This space is needed for UK HealthCare's Emergency Psychiatric Assessment Treatment Health program. The cost of the lease will not exceed \$310,000 annually (\$12.30 Base Rent + \$14.68 Amortized Fit-up). The effective date of the lease will be no later than June 1, 2024 (contingent upon the Committee's approval), with an expiration date of June 30, 2028.

The lease amendment is for 15,277 square feet of clinical space located at 912 Park Avenue, Ironton, Lawrence County, Ohio. This space is needed for UK HealthCare King's Daughters' Family Practice and Urgent Care clinics. The cost of the lease is \$481,716 annually (\$18 Base Rent + \$13.53 Amortized Fit-up). The effective date of the lease will be November 1, 2023 (contingent upon the Committee's approval) with an expiration date of June 30, 2030.

## APPROVAL OF LEASE

<u>Recommendation</u>: that the Board of Trustees authorize the Executive Vice President for Finance and Administration to negotiate and execute a building lease for the University of Kentucky at Eastern State Hospital, 1358 Bull Lea Road, Lexington, Kentucky.

<u>Background</u>: Pursuant to Governing Regulation II.E.2(d)(4)(f) all leases in excess of \$200,000 annually are approved by the Board of Trustees. The President or his designated representative is authorized to enter into leases and easements not exceeding \$200,000 in value.

UK HealthCare's Emergency Psychiatric Assessment Treatment Health (EmPATH) program which helps alleviate volume pressures in an Emergency Department by providing safe, effective behavioral health care in the right setting which promotes improved outcomes and quality of care. EmPATH creates a single point of entry into the behavioral health system by providing faster access to treatment for individuals experiencing a mental health crisis. This leased space will support the EmPATH program at the Eastern State Hospital location and will help eliminate unnecessary admissions to both Eastern State Hospital and the Good Samaritan Behavioral Health Unit.

The leased space will comprise of 11,500 rentable square feet with an annual rent not to exceed \$310,000.

KRS § 48.111 requires legislative authorization of all leases with an annual cost of \$200,000 or more. The lease has been authorized by the Kentucky General Assembly in the enacted 2022-24 Executive Budget of the Commonwealth. Contingent upon approval from the Board of Trustees, the lease will be reported to the Kentucky Capital Projects and Bond Oversight Committee in accordance with KRS § 56.823.
