RE: Capital Construction Project – KET Next Gen Conversion (NGC)

Dear Secretary Johnson:

KET is requesting an increase in the KET Next Gen Conversion project pursuant to KRS 45.760(6)(d). In 2021, Kentucky Educational Television requested and received approval of a capital construction project for the KET Next Gen Conversion (NGC) to replace end-of-life and failing equipment that will help ensure the technical reliability of the Network Center infrastructure and ready KET for the new broadcast industry standard, NextGenTV (ATSC 3.0). This work has allowed KET to continue to produce and distribute instructional and professional development resources that helped address learning loss experienced throughout the Commonwealth due to the COVID-19 pandemic. The original project budget was \$11,500,000, funded through the American Rescue Plan – Elementary and Secondary Schools Emergency Relief Funds. During the course of the project, due to equipment costs and interconnection needs, KET requested an additional \$1,500,000 in funding, bringing the total cost of the project to \$13,000,000. KET requests permission to increase the KET Next Gen Conversion (NGC) project budget to the full \$13,000,000.

KET creates and provides curriculum and evidence-based early childhood programming, workforce readiness resources, GED and literacy instruction, after school programs, summer enrichment, professional development and other educational resources that are made available through KET's statewide broadcast network, via KET.org and various streaming platforms. Used by more than two million Kentuckians each week and in every Kentucky public school district and by home school families, KET's trusted services offer significant learning opportunities for teachers, students, families, and learners of all ages.

KET's broadcast and production equipment prior to this project was close to 15 years old and rapidly exceeding its end-of-life with equipment failures becoming more frequent — including during live broadcasts. Many of these IT/computer-based systems could no longer run required software applications and cannot be updated with cybersecurity protections. To ensure the

technical stability and reliability of the Network Center infrastructure, failing KET systems must be replaced and ready for the new industry standard, NextGenTV (ATSC 3.0), authorized by the FCC in 2017. The new standard makes it easier to receive over-the-air signals with an antenna, enables at-home learning services, offers customizable audio for the hearing impaired, and allows the broadcast of internet-based content (without an ISP connection).

Authorization is requested, pursuant to KRS 45.760, for approval of a new Capital Construction project to construct the Jackson Field Maintenance Shop (FMS) in Jackson, Ky. This appropriation request for Design Services (Phase A-C) total \$1,274,564.00 and Construction Services (Construction, Contingency & Phase D Services) total \$14,400,000.00 for a total project cost of \$15,674,564.00. This project is 100% federally funded using Department of Defense Military Construction dollars reimbursable to the Commonwealth of Kentucky per the Military Construction Cooperative Agreement (MCCA). National Guard Bureau has authorized the Kentucky Army National Guard (KYARNG) and the Commonwealth of Kentucky to proceed with 35% of the design. The amount of \$757,346.00 is currently authorized of the total \$1,274,564.00.

This new 27,910 square foot Field Maintenance Shop will be built in Breathitt County. In accordance with provisions of KRS 45.760(7), I am writing to request interim authorization for the Blazer Library Renovation Project at Kentucky State University in the amount of \$1,700,00.00. This project will be 100% federally funded with the Title III Fund.

Blazer Library was originally constructed in the 1960s, and renovations and additions were completed in the 1980s and 1990s. The building contains systems that have been unchanged since the original construction. The building currently has failing windows, which have caused water infiltration and structural issues that need to be addressed immediately to prevent the creation of more damage and expenses. Additionally, the building's finishes have outlived their useful lives. The renovation project will replace windows, repair exterior deterioration, replace flooring, and update finishes. Resultantly, Blazer Library will become a space that can be better meet the needs of students.

The Kentucky State University Board of Regents approved this project on November 28, 2023 and the Council on Postsecondary Education approved the project on January 19, 2024.

Add Temperature sensors to the supply and return ducts to each inmate wing and zone. This will alert the Building Automated System if a smoke Control damper is open or closed. Create multiple access points into the attic. Replace the existing multizone unit with an outdoor VAV air handling unit. This is causing the issue of maintaining heat in the winter and cooling in the summer months. The dampers do not open or close correctly. The ductwork has collapsed internally and is leaking air into the attic in several areas.
