In accordance with the provisions of KRS 45.750-800, the Finance and Administration Cabinet is reporting the attached actions involving:

#### New Project - Federal Funds

General Government, Department of Military Affairs – London Readiness Center in the amount of \$1,200,000 funded with 50% Federal Minor Capital Construction Funds and 50% from the 2022-24 Armory Installation Facility Maintenance Pool.

### Appropriation Increase - Federal Funds

Education and Labor Cabinet, General Administration – Renovate McDowell Vocational Rehabilitation Center federal fund appropriation increase in the amount of \$1,500,000 from the U.S. Department of Labor bringing the total appropriation to \$6,000,000.

#### Dear Secretary Johnson:

Pursuant to KRS 45.760(6)(d), the Education and Labor Cabinet respectfully requests your approval for the Office of Vocational Rehabilitation to fund the complete building architectural renovation for the mechanical and electrical areas of the Charles W. McDowell Center in Louisville.

The Office of Vocational Rehabilitation is funded by the US Department of Education's Rehabilitation Services Administration. The estimated cost for this project is now \$6 million, all of which will be paid using existing federal funds. The Office of Vocational Rehabilitation currently has a federal appropriation of \$4.5 million and is requesting an increase of \$1.5 million in federal appropriation to complete this project.

Based on the recommendations in the architectural plan this quote includes fire suppression, plumbing, heating, ventilation and air-conditioning, control systems, electric power and lighting, communication, electric safety, and security, structural, architectural, elevator, built-in equipment, and other special items.

Authorized by the US Rehabilitation Act of 1973, the Office Vocational Rehabilitation serves Kentuckians with disabilities by providing them an opportunity to pursue meaningful employment and fostering independence. The Charles W. McDowell Center is a multidisciplinary residential rehabilitation training facility serving individuals who are blind and visually impaired from across the state in the Louisville metro area. The McDowell Center is the only residential rehabilitation facility within Kentucky that provides services to individuals throughout the Commonwealth who are blind and visually impaired. The programs and services provide individuals with visual disabilities the tools they need to become more independent in their homes, schools, workplaces, and communities. These programs include: low vision and blindness skills training, independent



living and older blind program, orientation and mobility services, deaf blind program and Bioptic driving. The building also houses a large unit of staff for the vocational rehabilitation program that provide employment services to all disability populations leading to competitive employment. Total number of individuals served at the McDowell Center for all programs and services in program year 23 was 2,766.

In an effort to keep this center operational and ensure continuity of service, it is necessary for the Commonwealth to repair or replace systems and equipment within the center. Currently, the McDowell Center is significantly limited in its ability to provide critical in-person services to individuals who are blind and visually impaired; therefore, your immediate approval is imperative.

The Justice and Public Safety Cabinet, on behalf of the Kentucky State Police, is requesting approval of an Emergency Repair, Maintenance or Replacement project to acquire an aircraft to replace the 1971 King Air 200 with a pre-owned, 2021 King Air 360.
