In accordance with the provisions of KRS 45.750-800, the Finance and Administration Cabinet is reporting the attached actions involving:

The Kentucky State Police is requesting approval per KRS 45.760 (7) to purchase a major item of equipment from the Federal Bureau of Investigation. This request in the amount of \$250,000 is for a 2009 Cessna 182T N632TK aircraft. Utilizing the GSA program, this purchase will be funded with 100% federal funds associated with the U.S. Justice Asset Forfeiture fund.

The Department of Criminal Justice Training requests approval to report a capital project (Boonesboro Firing Range – General Upgrades) in the amount of \$1,072,000 to the Capital Projects and Bond Oversight Committee pursuant to 2022 Regular Session, House Bill 1, Part II (4) Appropriations for Project Not Line Itemized. This project is funded with Restricted Funds in the amount of \$1,072,000 from the 2022-2024 Maintenance Pool.

This project includes clean up after minor flooding, returning the bathroom facilities to working order, run potable water to the site, replace failing 30+ year old roofs on the restroom & classroom buildings, and adding heat and air conditioning to both facilities to prevent weather related student emergencies.

In summary this will include the following:

Restroom / Storage Facility

- Strip damaged items out of building from flood.
- Remove failing roof, install low slope roof.
- Provide new heating and cooling.
- Remove rusted water damaged electrical box and systems.
- Replace electric box, lines, and fixtures.

Classroom building/live fire area

- Provide insulation system to assist with HVAC.
- Remove skylights to insulate for HVAC.
- Install HVAC.

- Lighting aimed toward range.

Program information

This firing range provides the resources needed to provide state mandated training within approximately 21 miles, a reasonable distance to the Department of Criminal Justice Training law enforcement academy and dormitory located at 4449 Kit Carson Drive, Richmond Kentucky.

The Department of Criminal Justice Training's mandated mission is fulfilled by using this property. Failure to maintain this property would mean the Department of Criminal Justice training would no longer have access to an outdoor firing range that would enable this agency to meet mandatory training requirements by accommodating full time police firearms training.

The Department of Criminal Justice Training (DOCJT) is responsible for training law enforcement professionals in all 120 counties of the commonwealth. Its mission, as described in KRS 15A.070, is to provide quality criminal justice training and services which advance the ability of Kentucky law enforcement to create a safe, secure environment in which to reduce crime and its cost to society.

DOCJT provides basic training to new law enforcement recruits through a 20-week Law Enforcement Basic Training Academy. Certified officers throughout the state return to DOCJT annually for a minimum of 40 hours of continuing education (in-service training). This training is provided to city, county, and public-funded university police officers; sheriffs and deputy sheriffs; airport police, fish and wildlife officers and commercial vehicle enforcement.

The Legislature of the Commonwealth of Kentucky has mandated that, "The Department of Criminal Justice Training shall establish, supervise and coordinate training programs and schools for law



enforcement personnel, subject to the limitations of KRS 15.440(1)(d) and (e) and 15.560, and any other justice or non law-enforcement-related personnel as prescribed by the secretary." KRS 15.070(1). In the Commonwealth, only Lexington, Louisville-Metro, Bowling Green, and the Kentucky State Police currently operate their own training academies. Consequently, The Department of Criminal Justice Training (DOCJT) is responsible for basic training and continuing education training (in-service) for every other law enforcement agency in the state of Kentucky. In addition, DOCJT trains court security officer, trains concealed carry licensing instructors, and has, as of March 11, 2019, been tasked with completely revising both basic and on-going training for certified school resource officers (SRO's) across the Commonwealth.

Every person in every class in each of those areas of training must receive firearms training. Those individuals who pass through the doors of DOCJT each year rely upon our agency to provide highly specialized technical and tactical training in the use of firearms and in the decision-making continuum implicated thereby. Every community and every school housing one of the officers we train relies upon our ability to adhere to the highest standards available for these courses. Our ability to maintain these standards, and, thereby, help maintain the safety of our communities and schools, is dependent upon access to firearms training facilities.

The Kentucky Department of Criminal Justice Training has been working with the Finance and Administration Cabinet's Division of Engineering and Contract Administration on the scope and design of the project. This project is ready to advertise.

The Department of Corrections (DOC) would like to request approval to report project CAZJ Luther Luckett Correctional Complex (LLCC) Fire Alarm Replacement, in the amount of \$2,440,000 to the Capital Projects and Bond Oversight Committee pursuant to 2022 Regular Session, House Bill 1, Part II (4) Appropriations for Project Not Line Itemized. This project is funded with General Funds from the Maintenance Pool 2022-2024 (CAL5) in the amount of \$2,172,298, Bond Funds from the Maintenance Pool 2020-2022 (C9SN) in the amount of \$247,702, and Bond Funds from the Maintenance Pool 2014-2016 (C73J) in the amount of \$20,000.

This proposed project is to replace the entire fire alarm system at the Luther Luckett Correctional Complex in Lagrange Ky.

The existing system has been in place since approximately 1993 and connects all buildings inside the security fence and one building outside the fence. This system has reached the end of its useful life and now requires excessive servicing, and parts are becoming difficult to procure, making the system extremely difficult to maintain. In addition, the facility is experiencing on average 3 to 4 false alarms per day, consuming additional time from security staff. The project consists of replacing all wiring, alarm devices, control panels, circuits, and associated components/software in the entire complex. When complete, LLCC will have a system current with today's standards and that will increase the life safety and security at the facility.

The project is broken down into three phases with the total cost encompassing all these phases. Phase one is to upgrade control panels, some workstations, and devices. Phase two is to replace equipment in dorm areas and phase three is to tie the system together and complete. During this time systems may be down for



extended times and a facility fire watch will be instituted. All work will be performed in coordination with LLCC maintenance/security staff.

The Kentucky Department of Education requests to report an amendment to a previously reported pool-funded project in excess of \$1,000,000 entitled Kentucky School for the Blind HVAC.

This project was reported to the Capital Projects and Bond Oversight Committee in April 2024 pursuant to 2022 HB 1, Part II, section 4. This request is to amend the fund source from the 2020-2022 bond-funded State Schools HVAC project to the 2022-2024 federal-funded State Schools HVAC Pool account authorized in HB 1 from the 2022 Regular Session. The project amount remains the same, \$4,950,000. These federal funds must be obligated by December 31, 2024.

This project will replace the original HVAC units for Evans Hall and Hartford Hall. Evans Hall was built in 1992 and serves as dormitory space for students and staff. Hartford Hall was built in 1969 and is the campus cafeteria. Both buildings have units beyond the recommended average life of 20 years and new HVAC units will be more energy efficient.

The Kentucky School for the Blind is a state operated facility operated by the KDE and located in Louisville, KY. There are over a dozen buildings on KSB's campus, with most being between 30 and 50 years old.
