Postsecondary Education, Kentucky State University has four Asset Preservation Projects that were approved by the KSU Board of Regents and by the Council for Postsecondary Education.

- The Electronic Locking System project totals \$1,500,000 and is funded 100% with Bond Funds from the 2024-2026 Asset Preservation Pool.
- The Mechanical and Electrical Upgrade project totals \$4,000,000 and is funded 100% with Bond Funds from the 2024-2026 Asset Preservation Pool.
- The Renovate Bradford Hall project totals \$1,800,000 and is funded with \$1,565,217.39 in Bond Funds from the 2022-2024 Asset Preservation Pool and \$234,782.61 in Restricted Funds, which satisfies the 15% match requirement.
- The Renovate Chandler Hall project totals \$9,970,000 and is funded with \$582,608.70 in Bond Funds from the 2022-2024 Asset Preservation Pool and \$87,391.30 in Restricted Funds, which satisfies the 15% match requirement. In addition, \$9,300,000 in Bond Funds from the 2024-2026 Asset Preservation Pool is utilized with no required match.

The Secretary of the Finance and Administration Cabinet is reporting a project greater than \$1,000,000 pursuant to 2024 Regular session, House Bill 6, Part II, (4). The project in the amount of \$2,923,387 is funded from the 2024-2026 Maintenance Pool in the amount of \$2,720,000 and the 2022-2024 Maintenance Pool in the amount of \$203,387.

The existing security fence at Luther Luckett Correctional Complex (LLCC) has a security risk area on the rear of the prison, where it has only a single perimeter fence and the existing sallyport has only a single security fence and gate system. The current prison security fence design standard is to have a redundancy double fence with a concrete rat wall foundation system and extensive razor wire. The current sallyport design is to have a double operating gate and double security fence system. This is a high priority to add these additions to the current prison security fence system to the rear and sallyport areas as soon as possible. The scope is to add approximately 2,400 lineal feet of perimeter security fence to the rear and additional fence and gate system to the sallyport. Without this security fence improvement, it poses great safety concern and threat to staff as well as the public.

The Department of Corrections (DOC) would like to request approval to report project CAU3 LLCC Perimeter Fence Improvements in the amount of \$2,923,387 to the Capital Projects and Bond Oversight Committee pursuant to 2024 Regular Session, House Bill 6, Part II (4) Appropriations for Project Not Line Itemized. This project is funded \$203,387 with General Funds from CAL5 Maintenance Pool 2022-2024 and \$2,720,000 Bond Funds from CBSD-Maintenance Pool 2024-2026.

The existing security fence at Luther Luckett Correctional Complex (LLCC) has a security risk area on the rear of the prison, where it has only a single perimeter fence and the existing sallyport has only a single security fence and gate system. The project budget is \$9,970,000. This will be funded using \$670,000 from the 2022-2024 Asset Preservation Bond Funds, which consists of \$582,608.70 from the Asset Preservation Bond Funds and \$87,391.30 in University funds, for the required 15% match and, \$9,300,000 from the 2024-26 Asset Preservation Bond Funds.

Chandler Hall was constructed in 1939. Its 28,000 square feet houses 115 students. It has undergone two renovations, most recently in 1993. The building suffers from deferred site maintenance, lack of system upgrades, and unaddressed moisture issues, as well as failing, dated, deteriorating, or damaged architecture (both exterior and interior). This renovation will make necessary renovations to the mechanical, electrical and plumbing (MEP) systems, architectural improvements of low maintenance flooring and building envelope repairs. This project will also take the opportunity to repurpose underutilized space to potentially increase the number of beds. Major construction is planned to begin in January 2025. Construction is scheduled to be completed by fall 2025.

The Kentucky State University Board of Regents approved this project on September 12, 2024 and the Council on Postsecondary Education approved this project on October 3, 2024.
