Pursuant to KRS §56.823 this is to report a new lease which exceeds \$100,000 annually. The University, after careful consideration, determined that this lease is in the best interests of UK and the Commonwealth of Kentucky.

The new lease is for 3,694 square feet of clinical space located at 135 East Maxwell Street, Fayette County, Kentucky. This space is needed for UK Healthcare's Speech Language Pathology Clinic. The cost of the lease will not exceed \$136,678 annually. The effective date of the lease will be July 1, 2025 (contingent upon the Committee's approval), with an expiration date of June 30, 2026.
