Pursuant to KRS 45.760(6), the Secretary of the Finance and Administration Cabinet is reporting a federal fund appropriation increase for the Cumberland Forest Conservation Program/Ataya project in the amount of \$350,000 for the Department of Fish and Wildlife Resources. This is a line-item capital project in the 2024-26 biennial budget and the increase will cover survey costs in excess of the amount originally estimated for this project which spans 54,000 acres in Knox, Bell, and Leslie counties. The increase is 100% federally funded from a Wildlife Restoration and Basic Hunter Education grant and brings the total of the project to \$7,000,000 from \$6,650,000 which is a 5.3% increase.

In accordance with HB 6, Part II, Paragraph 4 of the 2024-2026 biennial budget act, the Tourism Arts and Heritage Cabinet, on behalf of the Kentucky Department of Parks, is requesting to report a pool-funded capital project exceeding \$1 million. The roof project is estimated to cost \$1,402,000. This project will be funded from the bond-funded Lodge Replacement & Repairs Pool.

The roof replacement project at Lake Barkley Lodge will consist of removing and replacing 40,700 square feet of shingles and skylights, new down spouts and underground drainage system will be installed, and repairs will be made to existing copper gutters. Chimney liners will be installed, and chimney will be tuck-pointed and treated with a water repellent coating. New ice and snow guards will be installed over pedestrian traffic areas.

The Kentucky Department of Parks has been working with the Finance and Administration Cabinet's Division of Engineering and Contract Administration on the scope and design of the project. Project construction is ready to advertise.
