Agritourism Venue, Agricultural Education Expo, Community Garden Among Forty-Nine Agricultural Investments Approved

More than \$1.9 million invested in Kentucky Agricultural Development Funds

FRANKFORT, Ky. (May 18, 2018) – The Kentucky Agricultural Development Board approved \$1,955,691 in 49 agricultural diversification and rural development projects across the Commonwealth at its monthly board meeting.

State Investments:

Agritourism Venue

White House Lodge, LLC was approved for \$98,000 in State funds and \$25,000 in Daviess County funds for constructing an events facility/agricultural education building. For more information about this project, contact Suzanne White at (270) 929-1445 or suzannececilwhite@gmail.com.

County Investments:

School Greenhouse

Agricultural Education Expo

Community Garden

On-Farm Investments

The County Agricultural Investment Program (CAIP) offers 11 investment areas that give Kentucky agricultural producers the ability to increase net farm income, add value to their products and diversify their operation. CAIP benefits and enhances agriculture across the state by stimulating markets for Kentucky agricultural products. Eleven CAIPs were approved by the board totaling \$1,277,961 for Clark (\$157,500), Garrard (\$173,605), Hardin (\$95,000), Henry (\$150,000), Lincoln (\$200,000), Marion (\$170,962), McLean (\$37,000), Meade (\$50,000), Oldham (\$28,000), Warren (\$200,000), and Webster (\$15,894) counties.

In addition to these new approvals, an additional \$262,536 was approved to enhance an existing CAIP in Ballard (\$32,600), Clay (\$86,000), Leslie (\$10,000), Ohio (\$63,936) and Scott (\$70,000) counties.

Environmental Stewardship

The Deceased Farm Animal Removal Program serves as a measure to facilitate the coordination of environmentally sound and cost effective disposal of deceased livestock for Kentucky producers. Three Deceased Farm Animal Removal Programs totaling \$22,500 were approved for Clark (\$7,500), Henry (\$7,500) and Warren (\$7,500) counties.

Shared-use Equipment Program

The Shared-use Equipment Program assists broad-based community organizations with the purchase of farm equipment. The equipment purchased is made available for producer use in a specific county on a leased basis. One Shared-use Equipment Program totaling \$7,575 was approved for Boyd County.

Next Generation Beginning Farmer Program

The Next Generation Beginning Farmer Program was developed to facilitate the growing need for a specialized program that would benefit producers engaged in an agricultural operation from three to seven years. One Next Generation Beginning Farmer Program was approved by the board totaling \$45,000 for recipients in Henry County.

Youth Agricultural Incentives Program

The Youth Agricultural Incentives Program serves as a measure to facilitate the growing need for a specialized program that benefits youth actively engaged in agriculture. Five Youth Agricultural Incentives Programs were approved totaling \$46,000 for recipients in Henry (\$15,000), Ohio (\$10,000), Oldham (\$5,000), Owen (\$15,000) and Webster (\$1,000) counties.

On-Farm Energy Efficiency Program

The On-Farm Energy Efficiency Program provides incentives for Kentucky farm families to increase energy efficiency of existing equipment or facilities. Eighteen On-Farm Energy Efficiency Programs were approved totaling \$152,369 for recipients in Adair (\$9,710), Barren (\$9,770), Carlisle (\$9,050), Graves (\$20,300), Grayson (\$4,576), McLean (\$20,300), Muhlenberg (\$10,150), Ohio (\$18,300), Pulaski (\$11,560), Russell (\$10,009), Simpson (\$9,493), Union (\$10,150), and Warren (\$9,001) counties.

Great strides continue being made toward lessening Kentucky's dependence on tobacco production while revitalizing the farm economy by investing a portion of Kentucky's Master Settlement Agreement Funds into the Kentucky Agricultural Development Fund.

To date, Kentucky has invested nearly \$560 million in an array of county, regional and state projects designed to increase net farm income and create sustainable new farm-based business enterprises. These funding approvals, made possible by the Kentucky Agricultural Development Fund, represent just a few of the more than 5,800 projects approved, since the inception of the program in January 2001.

KADB Provides Additional Investment for Capital Access Loan Programs

FRANKFORT, Ky. (May 18, 2018) – The Kentucky Agricultural Development Board (KADB) recently approved \$5,000,000 for the Kentucky Agricultural Finance Corporation's (KAFC) revolving loan programs.

"I would like to thank the KADB for this much-needed investment in KAFC," Warren Beeler, Governor's Office of Agricultural Policy executive director, said. "KAFC's participation loan programs mitigate risk for lenders and improve cash flow for applicants by offering low interest rates. It is a win-win for tobacco settlement funds."

The KAFC provides below-market financial assistance to individuals and businesses interested in establishing or expanding their agricultural production or processing operations. This includes capital for the purchase of livestock, equipment and land, the construction/renovation of agricultural facilities and the investment into ag-related operations.

The demand for KAFC participation in agricultural projects has continued to increase since its revitalization in 2004. KAFC assets exceed \$75 million, with over 65 percent of the disbursed portfolio being comprised of Beginning Farmer loans (\$36.9 million), which continue to be a priority of the KADB and KAFC Boards. One hundred percent of principal and interest payments received by KAFC are invested directly back into the loan pool.

Blue Grass Community Action Partnership, Inc. (BGCAP) is requesting \$1,250 in Woodford County funds for a community garden.

APPLICATION SUMMARY

BGCAP will be creating a community garden located at Margaret Hall Manor Apartments. The elevated garden spots are available via application process to clients, including seniors, Adult Day and Head Start Families as well as local residents who want to raise gardens yet lack access to green space area. Management for this project is through BGCAP and will involve at least 8 supporting entities.

The total cost of this project is estimated at \$2,500 with the following funding sources:

- 1. Funds up to \$1,250 shall be available upon the execution of the Legal Agreement in the form of a cost-reimbursement grant.
- 2. Funds shall be disbursed upon the Recipient submitting itemized receipts/invoices and either a copy of a cancelled check or a copy of the relevant credit card statement as proof of payment. Cash purchases shall not be eligible for cost-reimbursement. The Recipient may request reimbursement for expenses up to 12 months from the date of the executed Legal Agreement and shall be returned to the Agricultural Development Fund. The applicant updated request is \$25,000 in Daviess County funds and \$98,000 in State funds for construction of a facility/venue/multi-use space.

APPLICATION SUMMARY

The applicant indicates that there will be a major focus on education-food & farming with some innovative programming that will utilize 50% of the new facility. The applicant also indicates that traditional farming will be a natural attraction for events and activities related to tourism. The construction will have the development of a small farm winery in-mind for future wine tastings and sales along with the planting of a vineyard and fruit and vegetable production.

The total cost of this project is estimated at \$619,175 with the following funding sources:

The applicant indicates that the greenhouse will be used for education and fundraising for the school They hope to use the vegetables within the school cafeteria.

The total cost of the project is \$30,037 with funding from the following sources: \$7,500 KADF Daviess County funds (secure) \$15,318 Individual donations (secure) \$7,219 Individual donations (unsecure)

PRODUCER IMPACT

The applicant indicates that over 60 families will benefit from this project.

Committee Recommendation:

The Red Application Review Committee recommends funding \$7,500 Daviess County funds, subject to the terms and conditions below:

- 1. Funds shall be available upon the execution of the Legal Agreement in the form of a cost-reimbursement grant.
- 2. Funds shall be disbursed upon the Recipient submitting itemized receipts/invoices and either a cancelled check or a copy of the relevant credit card statement as proof of payment. Cash purchases shall not eligible for cost-reimbursement. Funds may be drawn on the account for up to 12 months from the execution date of the Legal Agreement. The reimbursement rate shall be \$0.50 per dollar of approved documented expenses. Approved documented expenses may come from categories listed in the budget as an exhibit to the Legal Agreement.
- 3. The Recipient shall own and maintain the facility for at least five years from the execution date of the Legal Agreement.
- 4. The Recipient shall submit annual reports detailing the number of classes and students who use the greenhouse and any sales that arise from products grown.

FUNDING REQUEST

Grain Day, Inc. is requesting \$5,000 in Daviess County funds for the Ag Expo.

APPLICATION SUMMARY

The Ag Expo is a program and industry trade show that has been providing agricultural education programming for 44 years. The applicant provides this programming to allow farmers to meet the challenges as a result of less tobacco income and lower revenue margin in commodity grain production. Farmers face an anticipated lower revenue period through 2025. Information provided at Ag Expo will be used to help them better manage their business.

The total cost of the project is estimated at \$25,447 with funding from the following sources: \$5,000 KADF Daviess County funds (secure) \$20,447 Cash on Hand (secure)

PROJECTED PRODUCER IMPACT

The applicant states that attendance at daylong conference averages 600 participants, representing 400 families from Daviess and 13 surrounding counties.

Committee Recommendation:

The Red Application Review Committee recommends funding the request for up to \$5,000 in Daviess County funds subject to the terms and conditions below:

- 1. Funds shall be available upon the execution of the Legal Agreement in the form of a sponsorship grant.
- 2. The Recipient shall acknowledge in any awards, publications, brochures, websites, articles, advertising, correspondence, or promotional projects and activities that a portion of the funding for this project was provided by the KADF. The Recipient shall utilize, where possible, the KADF logo.
- 3. The Recipient shall submit copies of publications, brochures, etc. utilizing the KADB Logo.
- 4. The Recipient shall submit a report no later than 90 days after the event detailing expenses (including invoices), number and type of vendors and number of attendees at Grain Day.

Cash purchases shall not be eligible for cost-reimbursement. The Recipient may request reimbursement for expenses up to 12 months from the date of the executed Legal Agreement and shall be returned to the Agricultural Development Fund. The reimbursement rate shall be \$.50 per dollar of approved documented expenses.
- 3. The Recipient shall own and maintain the building for at least 5 years from the effective date of the Legal Agreement. In the event the Recipient sells the building prior to the expiration of the moratorium period, the Recipient shall refund the grant amount to the Kentucky Agricultural Development Fund on a pro-rated basis.
- 4. The Recipient shall submit annual reports detailing the usage of the facility including the number and type of animals sold/show and number of participants at each event. For educational programs, the Recipient shall include the number of workshops/events held and the number of attendees.
