# Technical Assistance Services and EKY-DIGS Program Among Twenty-Seven Agricultural Investments Approved More than \$3.4 million invested in Kentucky Agricultural Development Funds

**FRANKFORT, Ky. (Oct. 18, 2019)** –The Kentucky Agricultural Development Board approved \$3,407,624 in 27 agricultural diversification and rural development projects across the Commonwealth at its monthly board meeting.

The Kentucky Center for Agriculture and Rural Development, Inc. was approved for up to \$900,000 in State funds over a two year period to deliver technical assistance and provide educational opportunities to agricultural and rural businesses. # **Grain Storage Expansion**

Bagdad Roller Mills, Inc. was approved for up to \$200,000 in multiple County funds to expand its grain storage and handling equipment. For more information on this project, contact Charles Jefferies at (502) 747-8968 or brminc@bellsouth.net.

# **On-Farm Investments**

The County Agricultural Investment Program (CAIP) offers 11 investment areas that give Kentucky agricultural producers the ability to increase net farm income, add value to their products and diversify their operation. CAIP benefits and enhances agriculture across the state by stimulating markets for Kentucky agricultural products. Six CAIPs were approved by the board totaling \$1,553,000 for Casey (\$290,000), Clinton (\$135,000), Hart (\$350,000), Metcalfe (\$235,000), Robertson (\$293,000) and Scott (\$250,000) counties.

# **On-Farm Energy Efficiency Program**

The On-Farm Energy Efficiency Program provides incentives for Kentucky farm families to increase energy efficiency of existing equipment or facilities. Fifteen On-Farm Energy Efficiency Programs were approved totaling \$119,929 for recipients in Adair (\$3,283), Barren (\$14,288), Daviess (\$10,150), Graves (\$6,547), Hopkins (\$9,138), Letcher (\$10,150), Madison (\$10,150), Marshall (\$10,150), McLean (\$10,150), Ohio (\$20,300), Simpson (\$5,723), Washington (\$6,900) and Wayne (\$3,000) counties.

Great strides continue being made toward lessening Kentucky's dependence on tobacco production while revitalizing the farm economy by investing a portion of Kentucky's Master Settlement Agreement Funds into the Kentucky Agricultural Development Fund.

To date, Kentucky has invested more than \$605 million in an array of county, regional and state projects designed to increase net farm income and create sustainable new farm-based business enterprises. These funding approvals, made possible by the Kentucky Agricultural Development Fund, represent just a few of the more than 6,100 projects approved, since the inception of the program in January 2001.

Brangers Angus Farm A2019-0194

Application County: Hardin Date Submitted: 07/17/2019

Total Funds Awarded: \$10,000

#### **FUNDING REQUEST**

Brangers Angus Farm is requesting \$44,000 in State funds to build a compost bedded pack barn. This will be a Practical Implementation Project in Hardin County.

#### APPLICATION SUMMARY

The applicant plans to construct a compost bedded pack barn with a water catchment system. The barn will serve as a bedding area with a feeding alley and manure storage area. Rainwater will be collected from the roof of the pack barn as well a hoop barn and stored in a 15'x18'x8' in-ground water storage tank. The roof area has the potential to collect over 200,000 gallons of water per year. Excess water will be diverted to a local waterway by pipe to prevent erosion. The barn and water management practices will remove animals from pastures during extreme weather events, better manage manure storage, reduce runoff into streams, improve water quality and pasture quality, and increase net farm income.

The applicant intends to work with local extension, Hardin County Cattlemen's Association and schools to schedule workshops/classes to educate other farmers and share information and data gathered from the practices.

The total cost of the project is estimated at \$88,000 with the following funding sources:

\$44,000 KADF State funds

\$44,000 loan (pending)

#### PROJECTED PRODUCER IMPACT

The applicant states that two farm families will directly benefit, however education will be throughout Hardin County and neighboring counties.

# **Board Decision:**

Brangers Angus Farm was approved for up to \$10,000 in State funds to install a water harvesting system as part of a compost bedded pack barn. This will be a Practical Implementation Project in Hardin County.

Application County: Shelby Date Submitted: 08/27/2019

Total Funds Awarded: \$200,000

#### **FUNDING REQUEST**

Bagdad Roller Mills, Inc. is requesting \$100,000 in State funds and \$100,000 in Shelby County funds to expand its grain storage and handling equipment.

#### APPLICATION SUMMARY

The applicant plans to build a new grain receiving pit, purchase new grain elevator legs, pit and grain drags. The new grain storage and handling equipment will allow the applicant to receive corn from local farmers at a faster rate. The new system would work in conjunction with the new grain bin that has recently been constructed.

The total cost for the project is estimated at \$400,000 with funding from the following sources: \$100,000 KADF State funds (Unsecured) \$50,000 Shelby County funds (Secured) \$200,000 loan (Secured)

#### PRODUCER IMPACT

Bagdad Roller Mills, Inc. currently services 90 grain farm families in the following counties: Shelby, Henry, Spencer, Trimble, Anderson, Jefferson, Oldham, Owen, Scott, Fayette and Woodford.

# **Board Decision:**

Bagdad Roller Mills, Inc. was approved for up to \$200,000 in multiple County funds to expand its grain storage and handling equipment. If the applicant is unable to secure the full \$200,000 in County funds, the Kentucky Agricultural Development Board (KADB) shall make the difference between \$200,000 and the secured County funds available to the applicant in the form of a participation loan sold by the lender to the Kentucky Agricultural Finance Corporation (KAFC).

#### **FUNDING REQUEST**

Berea College, Grow Appalachia is requesting \$274,695 in State funds to expand Eastern Kentucky Direct Integrated Grower Support (EKY-DIGS) program in eastern Kentucky.

#### APPLICATION SUMMARY

The applicant is requesting funds to expand the "Eastern Kentucky Direct Integrated Grower Support" (EKY-DIGS) program to offer on-farm consultations and production planning for 64 farmers in 16 new counties, organize 24 hands-on field days, conduct an 8-month training for beginning farmers and develop interactive resources to help farmers make informed decisions critical to their farming operation.

The total cost of the project is estimated at \$672,060 with the following funding sources: \$274,695 KADF State funds (unsecure) \$297,365 USDA Beginning Farmer and Rancher Development grant (secured)

\$100,000 USDA NRSCS High Tunnel Regional Conservation Project (secured)

#### PROJECTED PRODUCER IMPACT

The applicant indicates more than 207 farm families have been impacted by EKY-DIGS.

#### **FUNDING REQUEST**

The Kentucky Center for Agriculture and Rural Development (KCARD), Inc. is requesting \$900,000 in State funds over two years to deliver technical assistance and provide educational opportunities to agricultural and rural businesses.

#### APPLICATION SUMMARY

KCARD is the primary assistance provider for producer-owned agribusiness development in Kentucky. KCARD assists both start-up businesses engaged in development stages of planning and existing businesses, looking to address new challenges or expand their market. Small and mid-sized businesses make up a sizable majority of Kentucky agribusinesses. KCARD is the most effective when establishing a relationship during the development phase of an operation and continuing to nurture the relationship over the long term, with a primary focus on financial sustainability.

Since 2001, KCARD has provided assistance and received inquiries from over 1,500 different entities and individuals. In 2018, over 400 different businesses or projects received KCARD help, ranging from farmers markets to meat processors and value-added producers to commercial kitchens. Of those, at least 280 had never received assistance from KCARD. As of August 2019, KCARD has 223 active clients, with monthly inquiries for assistance increasing by 8% in the past 12 months.

The total cost of this two-year project is estimated at \$1,837,580 with the following funding sources: \$400,000 USDA Rural Cooperative Development Grant (\$200,000 secured and \$200,000 pending) \$537,580 KCARD fee-based work (\$192,269 secured and remainder pending) \$900.000 KADF State funds

## PROJECTED PRODUCER IMPACT

Through direct interaction and benefits received through groups of producers, the applicant indicates that at least 1,500 producers and agribusinesses have been affected by this project since January 1, 2018.

The Kentucky Center for Agriculture and Rural Development, Inc. was approved for up to \$900,000 in State funds over a two year period to deliver technical assistance and provide educational opportunities to agricultural and rural businesses.

Application County: Perry Date Submitted: 08/30/2019

Total Funds Awarded: \$100,000

#### FUNDING REQUEST

The City of Hazard is requesting \$99,500 in State funds and \$500 in Perry County funds for the construction of a farmers market pavilion.

#### APPLICATION SUMMARY

The applicant states funds will be used for the construction of a permanent open-air farmers market pavilion in downtown Hazard. The structure will have a storage area and running water. The farmers market is currently located at picnic shelters in a Perry County park and must relocate when large events are at the park. The picnic shelters are in a low traffic area, whereas the new location will be in downtown Hazard. The applicant has partnered with Northfork Local Food and USDA to help construct the farmers market pavilion.

The cost of the total project is anticipated to be \$200,000 with funding from the following sources:

\$ 99,500 KADF State funds (unsecured)

\$ 500 Perry County funds (secure)

\$100,000 USDA Rural Development (secured)

#### PROJECTED PRODUCER IMPACT

The applicant states that 23 farm families will be impacted by this project.
