Edwards Woolworks is requesting \$24,838 in multiple County funds and \$24,838 in State funds to establish a wool mill.

APPLICATION SUMMARY

Edwards Woolworks seeks to establish a wool mill for Kentucky sheep producers to have an economical outlet to sell their wool. Currently, the cost of shearing, driving/shipping and the 18-month turnaround on out of state wool processing leaves many farmers without a viable market for their wool. By establishing a wool mill in Kentucky, not only will farmers have an outlet for their product, they will also have opportunity to expand into value added products. This mill would also allow local dyers, spinners, and weavers the ability to use locally sourced fleeces and yarns to showcase at their shops and festivals. KADF funds will be utilized to purchase specialty pin drafters, spinning plying frame, picker/carder, wool storage containers, building and wool from wool pool.

The total cost of the project is estimated at \$99,352 with funding from the following sources:

PROJECTED PRODUCER IMPACT

The applicant states that there are 2,000 wool sheep farmers in Kentucky that would directly benefit from a local mill.

The walk-in freezer will allow Nochelinda and affiliates inventory flexibility and allow for customer fulfillments throughout the year.

PRODUCER IMPACT

The applicant indicates four to five Bourbon county farmers will benefit for this project.

APPLICATION SUMMARY

Metcalfe County 4-H members that participate in the country ham project learn about: the history behind curing hams, science behind the curing process, food safety, meat production and food preservation. In order for the 4-H members to successfully complete the project, they must come to at least two of the three meetings to choose and prepare their hams. In order for the 4-H members to receive their hams at the State Fair, they must attend Country Ham Day to give their speech, otherwise they forfeit their second ham.

The total cost of the project is estimated at \$3,081 with the following funding sources:

PROJECTED PRODUCER IMPACT

FUNDING REQUEST

River Farm Nursery, LLC is requesting \$45,443 in State funds to implement pot-in-pot tree production and microirrigation system. This will be a Producer Implemented Project in Oldham County.

APPLICATION SUMMARY

River Farm Nursery, LLC is a field production nursery where the plants are produced in true soil. In this method, the plants can only be harvested during periods of dormancy, limiting sales to six months of the year. To obtain the ability to harvest and sell during the other half of the year, the farm has determined that a system of pot-in-pot production should be utilized. This is a containerized system that gives producers an opportunity to better manage nutrient and water inputs, expand sales in to other times of the year, and expand land use to hillsides not suited for traditional production methods. KADF funds will be utilized for purchasing the materials for irrigation, permanent pots buried in the ground and site preparation to make the area acceptable for tree production.

The total cost of the project is estimated at \$90,885 with the following funding sources:

\$45,442 Business Funds (secured)

Board Decision:

River Farm Nursery LLC, located in Oldham County, was approved for \$45,443 in state funds as a Producer Implemented Project (PIP) to implement pot-in-pot tree production and a micro-irrigation system. This project is part of the On-Farm Water Management Program.

Barr Farms Organic Produce, LLC. is requesting \$2,814 in State funds for a pond renovation and pump house construction for its beef cattle operation. This will be a Small Scale Grant project in Breckinridge County.

APPLICATION SUMMARY

Barr Farms Organic Produce, LLC. has marketed grass-finished beef for the last 13 years. Although acreage on one side of the farm has an adequate water source, the other side does not. Funds would be utilized to renovate a pond and install a concrete pump house with pumps, pipe and tanks to maintain a separate location for cattle to drink.

The total cost of the project is estimated at \$5,628 with the following funding sources: \$2,814 KADF State funds \$2,814 Personal Funds (secured)

Committee Recommendation:

The On-Farm Water Management Committee recommends denying the request due to lack of an established water source.

Gov. Beshear and Kentucky Agricultural Development Board Approve More Than \$1.7 Million for Projects Across Commonwealth Projects and programs approved span the diverse array of Kentucky agriculture

FRANKFORT, Ky. (Dec. 18, 2020) – The Kentucky Agricultural Development Board approved \$1,713,425 for agricultural diversification and rural development projects across the commonwealth at its monthly board meeting.

"As we cap off 2020, the December approvals from the Kentucky Agricultural Development Board show the full spectrum of agricultural activity in across our commonwealth," said Gov. Andy Beshear. "These approvals will provide funding for county programs, statewide horticulture support, meat processing, on-farm water management and more. This funding will help Kentucky's agriculturalists lead us into a prosperous future as we beat the coronavirus and sprint out of the pandemic in 2021."

State Investments:

Statewide Small Fruit Crops Program

The Kentucky Horticulture Council Inc. (KHC) was approved for \$500,000 in state funds over two years to expand the Kentucky Small Fruit Crops Program. This program supports the expansion of the small fruits industry in Kentucky by increasing production capacity and farm revenue for specialty crop growers.

Meat Processing Investment Program – Level 2

Kunkle Farm, located in Boone County, was approved for \$37,500 in state funds to purchase and install a walk-in cooler, freezer and various equipment for its custom processing facility.

Yoder's Custom Processing Inc., located in Garrard County, was approved for \$37,500 in state funds to purchase and install a freezer box and unit, and build an addition for its custom processing facility.

Spencer County Butcher Block, located in Spencer County, was approved for \$37,500 in state funds to purchase and install a band saw, meat saw, vacuum sealer and various kill floor equipment for its custom processing facility.
