The City of Cadiz is requesting \$93,500 in State and County funds to aid in constructing a farmers market structure to allow for an extended marketing period for producers.

APPLICATION SUMMARY

Funding will be used for building a 60'X100'X16' farmers market structure where the City of Cadiz's Farmers Market currently meets. The City of Cadiz will maintain this structure and hopes it will open the doors for producers to market their product on a year-round basis. The 2021-2022 class of the Trigg County Chamber of Commerce Leadership has identified this as a big need for their community and has raised funds to help build the farmers market structure. Most of the producers who will use this facility have been marketing their product in the area, but have not had a static and weather protected structure to market their product in. The applicant states the structure will not be exclusive to Trigg County producers.

The total cost of the project is estimated at \$187,000 with funding from the following sources:

- \$ 92,500 KADF State funds
- \$ 1,000 Trigg Co. KADF Funds (pending)
- \$ 80,408 Donations Raised (secured)
- \$ 13,092 Donations Needed (Pending)

PROJECTED PRODUCER IMPACT

The applicant states that 10 local producers will be directly impacted by this project and nearly 100 customers per day.

Gav's Meat Processing, LLC is requesting \$5,000 Butler County funds(2022) to purchase the following processing equipment: grinder, mixer and stuffer.

APPLICATION SUMMARY

Gavin McKinney will be the sole owner of Gav's Meat Processing, LLC. He has 12 years of experience in home processing and butchering. When the catfish processing facility (Gone Fishing) came up for sale, the applicant saw an opportunity to buy the building and renovate it into cattle and deer processing facility. The building is 3,500 square feet and currently has a 135.x22 walk-in in cooler. The applicant goal is to custom process on average 10 hogs and 5 beef per week. The applicant would like to offer USDA processing in the future. This project does not fit in any of the Meat Processing Investment Program Levels due to the being a startup custom processor.

The total cost of the project is estimated at \$15,000 with the following funding sources:

\$5,000 Butler County (2022) funds

\$10,000 Personal Funds (Secure)

Sugarloaf Mountain Meats and Processing is requesting \$224,850 in State funds to purchase a poultry-processing unit called "Plant in a Box", processing equipment and site preparation to expand the building to for the unit. The "Plant in a Box" is processing facility in a shipping container that is ready for USDA inspection .

APPLICATION SUMMARY

The applicant will focuses on processing poultry from their own land; they will also offer custom USDA processing for poultry. The applicant plans on processing a Processing Facility called "Plant in a Box", this is actual a poultry processing unit. The unit is 40 feet long and 9 feet tall and comes with most of the equipment needed to process poultry. The applicant also plans to purchase some additional processing equipment. The applicant has recently received a federal grant from USDA to help with the processing facility .

The total cost of the project is estimated at \$464,850 with the following funding sources:

\$224,850 State funds

\$25,000 in Multiple County funds

\$200,000 USDA (Secure)

\$40,000 Local Bank (Secure)

PRODUCER IMPACT

The applicant indicates the following counties would benefit from this project: Bath, Carter, Elliott, Fleming, Menifee, Morgan and Rowan County.

Board Decision:

Sugarloaf Mountain Meats and Processing was approved for \$224,850 in state funds as a forgivable loan and any county funds secured shall be awarded in the form of a cost-reimbursement grant in addition to State funds, not to exceed 50% of the total project cost. Funds will be used to purchase a poultry processing unit called "Plant in a Box" and equipment to expand their operation to a USDA certified poultry processing facility .

CAIP covers a wide variety of agricultural enterprises in its 11 investment areas, including, but not limited to, bees and honey; equine; forage; beef and dairy cattle; goats and sheep; horticulture; poultry; swine; timber and technology, as well as energy efficiency and production; farm infrastructure and water enhancement; marketing; and value-added production.

Deceased Farm Animal Removal (DAR)

The Deceased Farm Animal Removal Program serves as a measure to facilitate the coordination of environmentally-sound and cost-effective disposal of deceased livestock for Kentucky producers.

Four DAR programs were approved by the board totaling \$44,500:

Next Generation Farmer Program (NextGen)

NextGen addresses the growing need for a specialized program that would benefit producers ages 18 to 40 that have been engaged in an agricultural operation for a minimum of three years.
