#### **FUNDING REQUEST**

The Adair County Cattlemen's Association is requesting \$16,000 in Adair County funds to run a Youth Cost Share Program.

#### APPLICATION SUMMARY

Funding will be used to run a youth cost share program for Adair Co. youth ages 9-18. The cost share program will be cost reimbursement for youth focused on agriculture production practices set in the County Agriculture Investment Program (CAIP) guidelines. The maximum reimbursement amount per youth will be \$500. Typically, more than 32 youth apply for the program each year.

The total cost of the project is estimated at \$32,000 with funding from the following sources:

- \$ 16,000 KADF Adair County funds
- \$ 16,000 Youth portion of cost share

#### PROJECTED PRODUCER IMPACT

The applicant states that around 32 youth will be impacted by this project.

This business will target consumers on the West side of Davies County and has six listed farms that the applicant would source the produce and meat from.

**FUNDING REQUEST** 

Kenton County Fiscal Court is requesting \$250,000 in state and Kenton County funds to build a farmers' market pavilion in downtown Independence, KY.

#### APPLICATION SUMMARY

The Independence Farmers Market has been in existence since 2008. Currently, these producers set up on Saturdays in the parking lot of the Senior Citizens Building, using tents and temporary structures. Because of this setup, the weather is the most limiting factor.

By constructing this covered pavilion, the market season can be extended; allowing vendors to sell for at least 6 additional weeks.

The total cost of the project is estimated at \$741,750 with the following funding sources:

\$245,000 KADB State Funds

\$5,000 Kenton County Funds (Pending)

\$125,000 Durr Foundation Grant (Secured)

#### PROJECTED PRODUCER IMPACT

The applicant states that during 2021 and 2022, 11 farmers and producers sold at the Independence Farmers Market. They estimate that this facility will allow an additional 6-8 more producers to sell their products.

**FRANKFORT (March 17, 2023)** – The Kentucky Agricultural Development Board approved \$1,701,171 for agricultural diversification and rural development projects across the commonwealth at its monthly board meeting.

"The changing landscape of agriculture is dependent upon communities being able to diversify their agricultural outputs," said Commissioner of Agriculture and board chair Dr. Ryan Quarles. "The grants awarded by the Kentucky Agricultural Development Board goes a long way in helping make that a realization for the state's farming future."

#### **County Programs**

#### **County Agricultural Investment Program (CAIP)**

CAIP provides Kentucky agricultural producers with cost-share assistance on practices to allow them to improve and diversify their current farm operations. CAIP covers a wide variety of agricultural enterprises in its 11 investment areas, including, but not limited to, bees and honey; equine; forage; beef and dairy cattle; goats and sheep; horticulture; poultry; swine; timber and technology, as well as energy efficiency and production; farm infrastructure and water enhancement; marketing; and value-added production.

Nine CAIPs were approved by the board totaling \$1,091,696:

- Bath (\$284,900)
- Bell (\$30,000)
- Boone (\$13,507)\*
- Madison (\$235,000)
- Mason (\$66,150)\*
- Montgomery (\$83,000)

- Owen (\$150,000)

#### **Deceased Farm Animal Removal (DAR)**

The Deceased Farm Animal Removal Program serves as a measure to facilitate the coordination of environmentally-sound and cost-effective disposal of deceased livestock for Kentucky producers.

Two DAR programs were approved by the board totaling \$18,375:

- Bath (\$5,000)
- Mercer (\$13,375)

#### **Shared-Use Equipment Program**

The Shared-Use Equipment Program assists broad-based community organizations with the purchase of farm equipment. The equipment purchased is made available for producer use in a specific county on a leased basis.

Two Shared-Use Equipment programs were approved by the board totaling \$32,050:

- Laurel (\$15,300)
- Mercer (\$16,750)

#### Youth Agricultural Incentives Program (YAIP)

YAIP encourages youth to engage in and explore agricultural opportunities.

Two YAIPs were approved by the board totaling \$50,000:

- Bath (\$35,000)
- Mercer (\$15,000)
