Kentucky Agricultural Finance Corp. approves \$2,420,905 in loans

Aid bolsters beef, forage, poultry, and grain farmers across the commonwealth

FRANKFORT, Ky. (Sept. 8, 2023) – The Kentucky Agricultural Finance Corp. (KAFC) approved \$2,420,905 for 16 agricultural loans for projects across the commonwealth at its monthly board meeting.

Agricultural Infrastructure Loan Program (AILP)

Five Agricultural Infrastructure loans totaling up to \$545,305 were approved. Loan recipients were in Clinton (\$42,000), Graves (\$50,000, \$94,305 and \$109,000), and Wayne (\$250,000) counties. KAFC participates with lenders to provide financing to producers making capital expenditures for agricultural projects through the AILP. Eligible projects include permanent farm structures with attached equipment that improves the profitability of farming operations. Producers may be eligible for up to \$250,000 not to exceed 50 percent of the project.

Beginning Farmer Loan Program (BFLP)

Ten Beginning Farmer loans totaling up to \$1,750,600 were approved. Loan recipients were in Graves (\$200,000), Grayson (\$250,000), Hart (\$182,500), Hopkins (\$250,000), Metcalfe (\$85,000), Nicholas (\$54,625), Taylor (\$28,475 and \$200,000), and Webster (\$250,000 and \$250,000) counties. The BFLP is designed to assist individuals with some farming experience who desire to develop, expand, or buy into a farming operation. Beginning farmers may qualify for financing to purchase livestock, equipment, or agriculture facilities; to secure permanent working capital; for the purchase of farm real estate; or to invest in a partnership or LLC.

Large/Food Animal Veterinary Loan Program (LFAVLP)

A Large/Food Animal Veterinary loan totaling \$125,000 was approved for a recipient in Todd County. LFVALP is designed to assist individuals licensed to practice veterinary medicine in Kentucky who desire to construct, expand, equip, or buy into a practice serving large animal producers, including goat, sheep, swine, and other smaller food animals.

Goode's Riverside Creamery, LLC

FUNDING REQUEST

Goode's Riverside Creamery, LLC is requesting \$64,000 in multi county funds and \$150,000 in state funds to aid in constructing a creamery with retail space.

APPLICATION SUMMARY

Funding will be used to build a 60 x 120 steel building to house a creamery with retail space. Local farmers will be able to sell their KY Proud products in the retail space. The Goode family operates a dairy farm and will be processing their milk into value-added products at the creamery. They plan to sell milk, ice cream, milkshakes, and butter. Goode's Riverside Creamery specializes in non-homogenized milk, which is easier to digest and allows people with a lactose intolerance to consume it. The creamery will also have a viewing window that will allow consumers to watch the milk being processed. The applicant states that the closest value-added creamery is 75 miles west of their location. They will be the only value-added creamery in Central Kentucky.

The total cost of the project is estimated at \$1.6 million with funding from the following sources:

APPLICATION SUMMARY

Todd County Animal Clinic, PLLC currently operates as a mixed animal veterinary clinic servicing Christian, Logan, Todd, and Trigg counties. Dr. Orem currently provides services for cattle, equine, small ruminants, and small-scale chicken producers at this clinic. The applicant recently graduated from Auburn University's veterinary school in 2020 and stated she has a strong passion in offering quality care to our food animals. KADB funds will be used to purchase 10% of the Todd County Animal Clinic.

The total cost of the project is estimated at \$133,334 with the following funding sources:

Todd County Animal Clinic, PLLC is requesting \$100,000 in state and multi-county funds to purchase equipment necessary to provide services to large animals.

APPLICATION SUMMARY

Todd County Animal Clinic, PLLC currently operates as a mixed animal veterinary clinic servicing Christian, Logan, Todd, and Trigg counties. Currently, the three veterinarians at the clinic provide services for cattle, equine, small ruminants, and small-scale chicken producers at this clinic. KADB funds will be used to purchase a vet box for their truck, equipment for cattle working facility, cattle & equine ultrasounds, facility fencing, and a vet mobile vehicle.

The total cost of the project is estimated at \$133,334 with the following funding sources:

FUNDING REQUEST

Pulaski County Board of Education is requesting \$200,000 in Pulaski County funds to build an 80' x 150' agriculture complex building.

APPLICATION SUMMARY

The agriculture education program in Pulaski County has grown substantially in the past years. Many of these students do not have a farming background, so this program exposes them to the agriculture industry and what career opportunities are available.

The building will incorporate learning labs, an agricultural shop, livestock working facility, pens, scales, and an open-concept event area. This will give Pulaski County a place to educate students in the agriculture program, educate community members/farmers on animal handling and welfare techniques, as well as a place to have shows, sales, or other community agriculture events.

KADB funds will be used to purchase and construct an 80' x 150' steel building kit from Todd Truss.

The total cost of the project is estimated at \$400,000 with the following funding sources:

\$92,000 Concrete/Labor - 80'x150' Concrete Pad (Secured)

The applicant states that many students and farm families in Pulaski and surrounding counties will be directly affected by this project in the first year.

FUNDING REQUEST

Lincoln County Fiscal Court is requesting \$7,500 in county funds to aid in expanding the farmer's market pavilion.

APPLICATION SUMMARY

Funding will be used for building a 24' X 32' pavilion. The expansion will allow the market to grow from its current capacity of 10 vendors to accommodate 30+ vendors. The applicant states that 20 farm families will directly benefit as vendors in the first year. Additionally, residents will have a market for fresh produce close to their homes. The Fiscal Court will be acting as a fiscal agent, and the Broughtontown Community Center will provide the lot for the pavilion. Lincoln County tourism will be responsible for scheduling, renting, and other related tasks.

The total cost of the project is estimated at \$20,000 with funding from the following sources:

- \$ 7,500 Lincoln County funds (secured)
- \$ 7,500 Lincoln County Fiscal Court (secured)
- \$ 5,000 Broughtontown Community Center (secured)

PROJECTED PRODUCER IMPACT

The applicant states that 20 farm families will directly benefit as vendors in the first year.

3 Stone Farms, LLC A2023-0211

Application County: Henry Date Submitted: 07/28/2023

Total Funds Awarded: \$30,000

FUNDING REQUEST

3 Stone Farms, LLC. is requesting \$530,000 in multi-county and state funds to aid in building a confinement feeding barn to utilize stillage from distilleries to feed cattle.

APPLICATION SUMMARY

Funding will be used to build a 300' X 80' confinement feeding facility for finishing cattle. The facility will include slatted concrete floors to confine manure, solar infrastructure, rubber floor mats, and a watering system. The project will create five full-time jobs including two Barn Technicians, two Whole Stillage Transporters, and one Confinement Barn Supervisor. The facility will have an open-door policy to any land grant universities to perform animal health assessments, testing, and studies. The facility will also serve as a model for future confinement operations. The applicant states that Henry and surrounding counties will have the most benefit.

The total cost of the project is estimated at \$2,000,000 with funding from the following sources:

- \$ 500,000 KADF state funds
- \$ 30,000 KADF county funds
- \$ 820,000 Wilson Muir Bank Loan
- \$ 250,000 Wilson Muir AG Development Fund Participation Loan

The applicant states that Henry and surrounding counties will benefit the most and expects to impact 6-12 farm families in the first year by purchasing grain from them to finish the cattle.

Funded projects focus on agricultural diversification, rural development

FRANKFORT (Sept. 15, 2023) – The Kentucky Agricultural Development Board approved \$1,138,643 for agricultural diversification and rural development projects across the commonwealth at its monthly board meeting.

"Strengthening our agricultural communities starts with providing the means necessary for our producers to create diversity," said Commissioner of Agriculture and board chair Dr. Ryan Quarles. "The grants awarded today by the Kentucky Agricultural Development Board allows for the continuation of that pursuit to vary our agricultural pursuits across the state."

CAIP provides Kentucky agricultural producers with cost-share assistance on practices to allow them to improve and diversify their current farm operations. CAIP covers a wide variety of agricultural enterprises in its 11 investment areas, including, but not limited to, beef and dairy cattle; farm infrastructure, fencing, and water enhancement; equine; forage; goats and sheep; horticulture; poultry; swine; bees and honey; timber and technology, as well as energy efficiency and production; marketing; and value-added production.
