Kentucky Agricultural Finance Corp. approves \$3,583,856 in loans

Aid bolsters beef, forage, poultry, and grain farmers across the commonwealth

FRANKFORT, Ky. (Oct. 13, 2023) – The Kentucky Agricultural Finance Corp. (KAFC) approved \$3,583,856 for 23 agricultural loans for projects across the commonwealth at its monthly board meeting.

Agricultural Infrastructure Loan Program (AILP)

Seven Agricultural Infrastructure loans totaling up to \$1,009,350 were approved. Loan recipients were in Breckinridge (\$250,000), Calloway (\$42,750), Green (\$250,000), Marion (\$62,500), Ohio (\$250,000), and Pulaski (\$53,600 and \$100,500) counties. KAFC participates with lenders to provide financing to producers making capital expenditures for agricultural projects through the AILP. Eligible projects include permanent farm structures with attached equipment that improves the profitability of farming operations. Producers may be eligible for up to \$250,000 not to exceed 50 percent of the project.

Beginning Farmer Loan Program (BFLP)

Sixteen Beginning Farmer loans totaling up to \$2,574,506 were approved. Loan recipients were in Adair (\$250,000), Allen (\$171,756), Barren (\$112,500 and \$115,000), Breckinridge (\$175,000), Clark (\$135,000), Cumberland (\$250,000), Franklin (\$250,000), Graves (\$250,000), Grayson (\$125,000), Laurel (\$119,000 and \$200,000), Madison (\$86,250), McLean (\$75,000 and \$100,000), and Todd (\$160,000) counties. The BFLP is designed to assist individuals with some farming experience who desire to develop, expand, or buy into a farming operation. Beginning farmers may qualify for financing to purchase livestock, equipment, or agriculture facilities; to secure permanent working capital; for the purchase of farm real estate; or to invest in a partnership or LLC.



Kentucky State University (KSU) is requesting \$1,359,000 in state funds over a 2 year period (2024-2025) to aid in continuing its KSU Mini-Grant Program to help producers across the commonwealth.

APPLICATION SUMMARY

Since 2012, Kentucky State University (KSU) has provided assistance and mini-grants to small-scale and underserved farmers statewide in the areas of Organic Agriculture, Value-Added Products, Farmer Educational Support, Agroforestry, Emerging Agricultural Technologies, Food Systems Resiliency, and Beginning Beekeeper. KADB funds will be used for salaries, demo materials, supplies, and travel, and sub-awards to farmers.

The total cost of the project is estimated at \$3,747,000 with the following funding sources:

\$1,359,000 KSU Federal Funds

PROJECTED PRODUCER IMPACT

The applicant states approximately 190 farm families will directly benefit from this program in the first year and that all 120 counties could potentially benefit.

Kentucky Center for Agriculture and Rural Development, Inc.

FUNDING REQUEST

The Kentucky Center for Agriculture and Rural Development (KCARD), Inc. is requesting \$900,000 in state funds over two years to deliver technical assistance and provide educational opportunities to agricultural and rural businesses.

APPLICATION SUMMARY

KCARD is the primary assistance provider for producer-owned agribusiness development in Kentucky. KCARD assists both start-up businesses engaged in the developmental stages of planning and existing businesses looking to address new challenges or expand their market. Small and mid-sized businesses make up a sizable majority of Kentucky agribusinesses. KCARD is most effective when establishing a relationship during the developmental phase of an operation and continuing to nurture the relationship over the long term, with a primary focus on financial sustainability. Since 2001, KCARD has provided assistance and received inquiries from over 2,900 different entities and individuals. In 2022, over 670 different businesses or projects received KCARD help, ranging from farmers markets to meat processors and value-added producers to commercial kitchens. As of August 2023, KCARD has already assisted 401 clients in 2023 composed of producers, businesses and organizations, up from 331 this time two years ago. Within the 2024 and 2025 project years, KCARD expects to reach clients in all Kentucky counties.

The total cost of this two-year project is estimated at \$2,230,106 with the following funding sources: \$900,000 KADF state funds (Unsecured) \$400,000 USDA Rural Cooperative Development Grant (Pending) \$460,000 Appalachian Regional Food Business Center (Secured) \$100,000 USDA Regional Food Systems Partnership Grant (Secured) \$180,000 USDA AgVets Grant (Secured) \$190,106 KCARD fee-based and other grants (Secured)

PROJECTED PRODUCER IMPACT

The applicant indicates that at least 2,900 producers and agribusinesses have been affected by this project, with a projected impact to reach all 120 counties in the state.
