Kentucky Agricultural Finance Corp. approves \$1,590,265 in loans

Financing bolsters beef, forage, poultry, and grain farmers across the Commonwealth

FRANKFORT, Ky. (July 12, 2024) – The Kentucky Agricultural Finance Corp. (KAFC) approved \$1,590,265 for 10 agricultural loans for projects across the Commonwealth at its monthly board meeting.

Agricultural Infrastructure Loan Program (AILP)

Five Agricultural Infrastructure loans totaling \$817,790 were approved. Loan recipients were in Allen (\$45,614 and \$250,000), Breckinridge (\$130,313 and \$141,863), and Green (\$250,000) counties. KAFC participates with lenders to provide financing to producers making capital expenditures for agricultural projects through the AILP. Eligible projects include permanent farm structures with attached equipment that improves the profitability of farming operations. Producers may be eligible for up to \$150,000 not to exceed 50 percent of the project.

Beginning Farmer Loan Program (BFLP)

Five Beginning Farmer loans totaling up to \$772,475 were approved. Loan recipients were in Anderson (\$194,225), Grayson (\$200,000), Meade (\$22,000), Taylor (\$250,000), and Union (\$106,250) counties. The BFLP is designed to assist individuals with some farming experience who desire to develop, expand, or buy into a farming operation. Beginning farmers may qualify for financing to purchase livestock, equipment, or agriculture facilities; to secure permanent working capital; for the purchase of farm real estate; or to invest in a partnership or LLC.



Clark County Fiscal Court is requesting \$7,250 in Clark County funds to make upgrades to the county's dead animal composting facility.

APPLICATION SUMMARY

The Clark County Compost Facility came online in April of 2021, to compost animals picked up in the county's free Deceased Farm Animal Removal (DAR) program. The facility is in full operation, processing more than 1200 farm animals a year and generating more than 500 tons of viable soil amendment that is used all over the state.

KADB funds will be used to install electrical service at the facility and construct a small office structure.

The total cost of the project is estimated at \$14,500 with the following funding sources: \$7,250 KADB Clark County Funds

\$10,000+ General Fund line-item Clark Co Fiscal Court (Secured)

The applicant states that over 200 farms or individuals will benefit from this project.

FUNDING REQUEST

The Grayson County Extension District Board is requesting \$1,000 in Grayson County funds to have a Poultry Specialist from the University of Georgia visit local farms and host a hot weather workshop.

APPLICATION SUMMARY

Funding will be used to bring a Poultry Ventilation Specialist from the University of Georgia for a 3-day event for poultry producers, ANR Agents, and Flock Advisors. The Specialist will visit 4 farms in Grayson County and 4 farms in McClean County. The event will also include a Hot Weather workshop in Ohio County with information on ventilation and litter management. The applicant states that 14 counties will be invited to the event. The applicant is collaborating with McClean County on this project. However, the applicant is only requesting funding for Grayson County's portion of the event.

The total cost of the project is estimated at \$2,000 with funding from the following sources: \$1,000 Grayson County Extension Service \$1,000 Grayson Co. Funds

PROJECTED PRODUCER IMPACT

The applicant states that at least four farms will be directly impacted. The event will also educate ANR Agents, Flock Advisors and other poultry producers. The applicant anticipates 150-175 attendees.

APPLICATION SUMMARY

The applicant states that this project will bring a ventilation specialist from the University of Georgia to Kentucky during June to participate on farm visits. This specialist will help evaluate poultry operations and work through the different issues that they may experience throughout the year. The farm visits are an outreach tool for the McLean County Extension Service to directly assist poultry producers with updated information on bird health and barn issues. Both Tyson and Perdue will be involved in helping the applicant and specialist host an ANR UK agent /Flock advisor training with producers. A similar application submitted by Grayson County Extension Board has been submitted, however, the applicant has expressed these are two separate applications. Grayson County plans on hosting one of the University of Georgia speakers in their county and will use only Grayson County Agricultural Development Funds and a match from Grayson County Extension Board.

The total cost of the project is estimated at \$6,750 with funding from the following sources:

The applicant states that the Jepson family and the Pearson family will benefit directly from the project in the first year.

The applicant plans to construct an AI facility catered to small ruminants. The center will provide climate-controlled conditions and coordinate AI and ET work for groups of producers. It will enable producers across the state to access nationally recognized AI and ET providers.

Funding will be used to build additional grain bins at the Danville grain elevator. The expansion will increase the storage capacity for grain. The applicant states that the Danville grain elevator allows local growers the opportunity to merchandise grain and reduce the time and money spent traveling while offering competitive basis for grain . The Danville grain elevator opened in October 2023 with the initial storage capacity of 640K bushels, which was filled by mid-December. To date, 720K bushels have been taken in at the Danville location. The applicant states that to date, twelve new customers were added between the freeing of space at their Loretto location and the new facility in Danville.

The total cost of the project is estimated at \$1,551,160 with funding from the following sources: \$1,000,000 KADB Participation Loan \$551,160 Combination of Loan and Cash

PROJECTED PRODUCER IMPACT

The applicant estimates that fifteen farm families will be directly impacted by this expansion.
