Kentucky Agricultural Finance Corp. approves more than \$2.7 million in loans

Financing bolsters beef, forage, poultry, and grain farmers across the Commonwealth

FRANKFORT (Sept 13, 2024) – The Kentucky Agricultural Finance Corp. (KAFC) approved 16 agricultural loans totaling \$2,700,098 for projects across the Commonwealth today at its monthly board meeting.

Agricultural Infrastructure Loan Program (AILP)

Five Agricultural Infrastructure Loans totaling up to \$931,500 were approved. Loan recipients were in Allen (\$250,000), Butler (\$250,000), Hardin (\$56,500), Logan (\$125,000), and Wayne (\$250,000) counties.

KAFC participates with lenders to provide financing to producers making capital expenditures for agricultural projects through the AILP. Eligible projects include permanent farm structures with attached equipment that improves the profitability of farming operations. Producers may be eligible for up to \$250,000 not to exceed 50 percent of the project.

Beginning Farmer Loan Program (BFLP)

Ten Beginning Farmer Loans totaling up to \$1,768,598 were approved. Loan recipients were in Adair (\$174,924, \$141,312, and \$250,000), Crittenden (\$215,000), Daviess (\$250,000), Hart (\$168,750), Ohio (\$250,000), Owen (\$158,437), Taylor (\$30,175), and Whitley (\$130,000) counties.

The BFLP is designed to assist individuals with some farming experience who desire to develop, expand, or buy into a farming operation. Beginning farmers may qualify for financing

to purchase livestock, equipment, or agriculture facilities; to secure permanent working capital; for the purchase of farm real estate; or to invest in a partnership or LLC.

Diversification through Entrepreneurship in Agribusiness Loan Program (DEALP) One Diversification through Entrepreneurship in Agribusiness Loan totaling \$250,000 was approved. The loan recipients was in Madison County.

DEALP is designed to assist agri-entrepreneurs with the purchase, establishment, or expansion of a business that sells agricultural products or services to farmers or consumers.

FUNDING REQUEST

Hampton Premium Meats is requesting \$1,000,000 in state funds to support the expansion of their facility to increase the harvest and holding capacity.

APPLICATION SUMMARY

In the two and a half years of ownership, the applicant states that tremendous upgrades have been made that drastically increased the demand of their services, harvested over 16,000 animals in 2023, and the facility is now Global Food Safety Initiative (GFSI) certified. This expansion project would include a hot box, carcass cooler, offal room, processing room, and a climate-controlled loading dock, with the additional rail space increasing holding capacity of approximately 450 beef or 900 hogs. At minimum, the applicant estimates up to 10 jobs being created to cover processing, fabrication, and quality assurance. To date, the applicant has been awarded \$339,000 in Kentucky Agricultural Development Funds in the Meat Processing Investment Program Level 3 for facility upgrades and a general KADF project to cover Halal consultation fees. Separately, the previous owner of Hampton Meat Processing was awarded \$275,038 in CARES funds administered by KOAP.

The total cost of the project is estimated at \$4,628,871 with funding from the following sources: \$1,000,000 KADF State Funds (Unsecured) \$3,628,871 Private Investors (Secured)

PRODUCER IMPACT

The applicant estimates that several farm families will benefit from this project ranging from their customers in Christian, Todd, Logan, Warren, Simpson, Lyon, Caldwell, Hopkins, McLean, Daviess, Webster, Barren, Edmonson, Grayson, Hardin, Monroe, Jefferson, Pulaski, and Woodford counties. In addition, there are also out of state customers from Tennessee and Alabama.

FUNDING REQUEST

The University of Kentucky Research Foundation is requesting \$352,145 in State funds over a two-year period to support the state's Viticulture and Enology Extension Program.

APPLICATION SUMMARY

The applicant indicates UK will continue research focused on vineyard management and winery techniques specific to varieties know to thrive in Kentucky and newly released varieties. The applicant plans to help growers maneuver different field variations, by teaching adapting wine styles for those variations that are needed. The applicant's goal for this project is to provide research-based recommendations on new and existing vineyard methods and wine styles best suited to our climate, communities, and consumer preferences. Wine sales began on June 14, 2018, and have generated over \$40,000 which has been put directly back into the extension and research activities at UK. The UK Research Foundation has received funds for the State Viticulture and Enology Extension Program in 2014, 2016, 2018, 2020, and 2022. The total KADF received is \$2,402,081.

The total cost of the project is estimated at \$704,290 with funding from the following sources:

\$352,145 KADF State funds (Requested)

\$133,572 UK Faculty Salaries & Fringe (secured)

\$218,573 Uncovered Indirect Cost (secured)

PROJECTED PRODUCER IMPACT

The applicant indicates that there are 74 wineries, more than 150 individual grape producers, and roughly 225 acres in Kentucky that will benefit from this project.

Funding will be used to purchase an ultrasound machine with probes. The current ultrasound machine at the clinic has malfunctioned and a replacement is needed to continue to provide bovine pregnancy diagnosis. The applicant states that 40-50 clients in 7 counties utilize their services for bovine pregnancy evaluation.

CAIP covers a wide variety of agricultural enterprises in its 11 investment areas, including, but not limited to, beef and dairy cattle; farm infrastructure, fencing, and water enhancement; equine; forage; goats and sheep; horticulture; poultry; swine; bees and honey; timber and technology, as well as energy efficiency and production; marketing; and value-added production.
