# MFAST Purpose

- Administering the trust fund created under KR 36.470.
- Attached to the Department of Military Affairs (KDMA)
- Kentucky service members in financial need related military service
  - A last resort, having exhausted all other avenues of support
- Adoption Assistance for Kentucky service members
  - Actual cost up to \$5000 or \$7,000 for special needs adoptions

# **Key Activities**

### HB 715 – MFAST Fund Expansion

- Removal of "post-deployment" provision to eligibility
- Expanded Adoption Assistance Program to include former members of the KYNG
- To allow adoption of step-children to qualify

### **Request for Funding Pause**

- Effective stewardship of Trust funds (decrease in deployments)
- Threshold set at \$200,000
- Will include comments regard future funding in Annual Report
