## What are Special Purpose Governmental Entities (SPGEs)

SPGEs are independent, political subdivisions of the state, government entities that exercise less than statewide jurisdiction and are organized for the purpose of performing specific services within limited boundaries.

## Main Focus – Today

Our team will continue to monitor the requirements under KRS 65A that SPGEs register and submit certain financials online. Our Branch developed and implemented manual processes to assist SPGE compliance. Moving forward, DLG plans to transition to a new automated system for SPGEs.

## DLG Responsibility per KRS 65A

- Create and maintain:
  - Online central registry
  - Online reporting portal
  - Online public access portal
- Monitor compliance:
  - Track status changes
  - Prepare statutorily required reports
  - Activate noncompliance procedures

## LRC - SPGE Compliance Report

- The submitted report includes:
  - Data as of September 25, 2018
    - Data is accurate as of report date
    - Compliance percentages may move up or down depending on the SPGEs status at the time of report. Example: Dissolutions, Merges, Declassifications, Hold
    - Approximately 9,622 individual records
    - Five records for most SPGEs
    - Compliance by fiscal year

  - Create a new SPGE reporting portal and central registry;
  - Create a new SPGE public portal for citizens to view current and historical submissions;
  - Automate existing manual processes such as:
    - Compliance Administration
    - Compliance Reporting
    - Compliance Notifications
    - Fire Department Exiting and Entering the System
    - Municipal Utilities Buying and Selling Components
- Provide online tutorials for submitting and reviewing data;
- Continue to provide annual SPGE training for Financial Disclosure and Tax Rate Calculation, to be held at the Area Development Districts.
