SUBJECT: FY 2025 Hunger Relief Program Report: KRS 150.150(3)

According to KRS **150.150(3)**, the Kentucky Department of Fish and Wildlife Resources (KDFWR) must maintain a separate account for volunteer donations to Hunger Relief during vehicle registration as outlined in KRS **186.050(15)**. KDFWR is also required to set aside at least \$25,000 from the Game and Fish Fund for hunger relief related to wildlife management, providing an annual report to the Governor and the Legislative Research Commission.

This memorandum is KDFWR's report for Fiscal Year 2025. The attached chart shows that the department received **\$0.00** in revenue but expended **\$25,000**. Additionally, KDFWR allocated **\$194,847.00** through federal funds for conservation efforts aimed at hunger relief.

In FY 2025, KDFWR contracted with Hunters for the Hungry, a non-profit organization, for \$25,000 to support expenses related to the processing and distribution of donated hunter-harvested deer (contract **PON2 660-2400002651**). This contract will continue for an additional two years with the same funding, and expenditures will be reported annually.
