RE: ALTERNATIVE METHODS FOR PRORATING EMPLOYER CONTRIBUTIONS FOLLOW UP

In response to testimony provided during the May 20, 2019 meeting of the Public Pension Oversight Board, a request was made for more information regarding projected employer contributions for quasi-governmental employers participating in the Kentucky Employees Retirement System (KERS) nonhazardous plan under an alternative method of calculating unfunded liability amortization payments based on the agencies' actual liability.

LRC staff has received the following information from the Kentucky Retirement Systems as calculated by their actuary, GRS Consulting, Inc. The information attached is a pro forma calculation of employer contributions (both pension and insurance combined) for FY 2020, along with the impact on each employer of allocating the unfunded liability amortization cost based on their actual liability (proposed method) and payroll (current method).

All information provided is based upon the June 30, 2018 actuarial valuation. GRS Consulting has provided the following note to stakeholders, which points out that future calculations may vary as a result of recent assumption changes and possible legislative action:

"To stakeholders who are using this information, the purpose of this pro forma is to provide stakeholders an understanding of the magnitude of change in cost for each quasi agency if the allocation of the amortization cost is modified. We do not recommend using the total contribution amounts as budgeting information for each agency as their future contribution requirements will change, due to the adopted assumption changes as well as possible legislative changes related to subsidies provided to the quasi agencies." – GRS Consulting, Inc.
