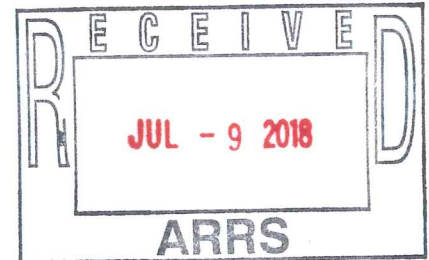

KRS 317A.040(1) authorizes the board to delegate staffing decisions to the administrator. KRS 317A.060 requires the board to promulgate administrative regulations that include protecting the public and establishing examination requirements. KRS 317A.120 requires trained proctors at examinations.
