**301 KAR 2:172. Deer hunting seasons, zones, and requirements.**

**Page 1**

**Section 1(1)**

**Line 16**

After "Section 1. Definitions. (1)", insert the following:

"Additional deer permit" means a permit that allows the holder to take up to two (2) additional deer beyond those allowed by the statewide permit in the following combinations:

(a) One (1) antlered deer and one (1) antlerless deer; or

(b) Two (2) antlerless deer.

**Pages 2 and 3**

**Section 1(10)**

**Lines 17 through 4**

After "(10)", delete the following:

"Deer management permit" means a permit that allows the holder to take up to fifteen (15) additional deer beyond those allowed by the statewide permit in the following combinations:

(a) One (1) antlered deer and no more than fourteen (14) antlerless deer; or

(b) No more than fifteen (15) antlerless deer.

Renumber each subsequent subsection accordingly.

**Page 3**  
**Section 1(16)**  
**Lines 11, 12, and 13**

After ""Special deer hunt" means a", insert the following:

one (1) or two (2) day deer hunt sponsored and overseen by the department on private land that:  
(a) Allows a novice deer hunter to use a modern gun outside of modern gun deer season; and  
(b) Shall be made available only to a:  
1. Kentucky resident;  
2. Person enrolled as a resident or non-resident student in a public or non-public postsecondary institution located in Kentucky; or  
3. Member of the United States military or his or her spouse or children stationed at a military base in Kentucky

Delete the following:

department-sponsored one (1) or two (2) day deer hunt on private land that allows novice deer hunters to use a modern gun outside of modern gun deer season

**Section 2(2)**  
**Lines 12 through 17**

After "(2)", delete the following:

A deer management permit shall not be valid unless accompanied by a valid Kentucky hunting license and a statewide deer permit or a license or permit that grants statewide deer hunting privileges. (3)

**Page 8**  
**Section 5(8)**  
**Lines 12, 13, and 14**

After "hunting requirements.", delete the following:

(8) A deer hunter may take antlerless deer with a modern gun in Zone 1 counties for two (2) consecutive days beginning on the last Saturday in September.

**Section 7(2)**

**Line 18**

After "antlerless deer in Zone 1", insert the following:

if the person has purchased the appropriate additional deer permits

**Page 10**

**Section 7(7)**

**Lines 11 through 13**

After "December muzzleloader season.", delete the following:

(7) A person shall purchase a deer management permit in order to harvest more than four (4) deer.

**Section 12(1)(c)**

**Line 20**

After "(c)", insert "Only".

Lowercase "Be".
