

## **CHILD CARE SURVEY**

A Month into Reopening



Analysis based on 592 responses from 102 counties (as of July 12, 2020)
Approximately 2,075 total licensed/certified providers

#### PROVIDER TYPE & CAPACITY:

- Type I 499 (84%)
- Type II -23 (4%)
- Family Child Care Home 70 (12%)
  - 51,912 total capacity of respondents
    - o 41, 631 enrollment prior to COVID-19
    - o 24,042 enrollment after reopening

#### CHILD CARE ASSISTANCE PROGRAM (CCAP):

- 84% of respondents accept CCAP
- Current CCAP enrollment of respondents 7093 children

#### **REOPENING STATUS:**

- Reopened 469
- \*Haven't reopened yet but a reopen date is set 69
- Haven't reopened yet and no date is set 17
- No response 37

#### WILL YOUR CENTER HAVE TO CLOSE IF GROUP SIZE RESTRICTIONS ARE NOT REMOVED?

- Yes \*43% of respondents
- No 57% of respondents
- \*214 providers who accept CCAP reported they would close (4,421 children)

#### **WEEKLY INCOME LOSS:**

- 299 respondents reported weekly income loss
  - o \$3,600 average loss per center (of the 299 respondents)
  - o \$1,076,400 total weekly loss

#### **FACILITY TOURS:**

- 57% reported need for in person tours to build capacity/enrollment
- 43% reported no need for in person tours

#### YEARS IN BUSINESS?

• 18 years – average number of years providing child care services

#### TYPES OF PROVIDERS:

<u>Certified Family Child Care Home.</u> A private home that provides full or part-time care day or night for six (6) or fewer children who are not the children, siblings, stepchildren, grandchildren, nieces, nephews, or children in legal custody of the provider.

<u>Licensed Type II Center.</u> This child care center shall be a primary residence of the licensee in which child care is regularly provided for seven (7), but no more that twelve (12) children including the children related to the licensee.

<u>Licensed Type I Center.</u> This child care center shall be licensed to regularly provide child care services for four (4) or more children in a nonresidential setting or thirteen (13) or more children in a designated space separate from the primary residence of the licensee.

- No transportation services are to be provided by either entity
- Children should not be permitted to attend longer than 13 hours at any given time
- No discipline should be utilized
- Each location should account for 30 square feet per child
- · Children should be combined by age group

#### Staff Qualifications:

- o Must be eighteen years of age
- Have a completed a Background Check or the following: AOC/ KSP criminal records check, and a Child Abuse and Neglect Check
- o Must never be left alone with children
- o At least one staff member on site must be current CPR for infants/adults and first aid
- o Staff should not exceed a twelve hour shift if at all possible

#### Enrollment:

- o Identifying information for each child should include:
- Basic identifying information including parents contacts
- o Documentation of preferred physician
- o Emergency contact
- o Identified allergies and other medical concerns
- o Authorized pick up approval
- o Authorization from parent to seek medical attention if needed

#### Nap/Rest

- o Parents shall provide adequate bedding for rest which is age appropriate
- o Rest periods are recommended for ages four and younger
- o Infants and toddlers should be allowed to sleep on demand

#### Food

- o A meal or snack should be offered every three hours or brought in from home
- Children should be allowed access to water at all times
- Parents may be required to provide prepared meals
- o Infants and toddlers should be permitted and supported to eat on demand (age appropriate food to include formula, etc.)



o Hand washing must occur prior to meals for both staff and children and after

#### Programming

- Access to age appropriate materials
- o Balance of quiet and active play

#### Access to Restrooms

- Each location must have adequate restrooms to include working toilets, running water in sinks, soap, and hand drying materials
- o Hand washing should occur frequently and as referenced above
- o Diaper changing stations should include safe and sanitized equipment
- o No hazardous/toxic materials should be in presence of children

#### -Health Monitoring

All children and staff should receive screening for illness at a minimum of every two and a half hours to include observation and temperature checks


#### **EMERGENCY REGULATIONS**

COSTS. WE WILL BE AT ZERO.

I have 2 schoolage programs that operate within 2 local elementary schools. Each are licensed for about 40 children. The emergency regulations limit me to 10 children in the school. This would mean that we remove the children who have been together all day from the "school cohort" and mix them in the community. I would also have to inform 60 children they no longer have afterschool care.



- Why are childcare centers limited to groups of 10 and yet swimming pools, beaches, amusement parks, trampoline venues all have children in larger group sizes.
- We mask, we constantly sanitize, we limit contacts, but, we have ZERO control over where the children go when they leave our care -T-Ball, soccer, swimming, vacation, parties.
- We are the only ones closed for 14 days. We are the ones with mandated consequences.
- Why do schools have recommendations, and we have regulations?
- Maximum numbers of pupils in class K-3rd is 24.

Marshall County High School - 4 Co-op placements annually for seniors to earn their Child Development Associate Credential. 5 placements annually for juniors in the Child Development Program to earn the Commonwealth Child Care Credential.

Murray State University - 6 practicum placements annually for Interdisciplinary Early Childhood Education bachelor's and master's degree students.

Western Kentucky Community and Technical College System - 7 practicum placements annnually for Interdisciplinary Early Childhood Education associate's degree students.

#### SUBSIDY...IF YOU CAN AFFORD IT

KY Child Care Subsidy pays \$20/day for qualifying families. BUT that leaves a -\$57/week or -\$3,484/year shortfall per child\*. Sadly, we serve only 5 subsidy children.

#### **MEETING UNIQUE NEEDS**

In addition to neurotypical children, we serve children with developmental delays, children with unique dietary needs, children born addicted to heroin, children diagnosed with Austism Spectrum disorders, foster children and children expelled from other programs due to behavioral challenges.
