



Current Issues: Aging & Disabilities


- **KY ranks 50th** in % of long term services and supports dollars spent on home and community based services for older people and adults with physical disabilities
 - 81% of dollars spent on long term services and supports for older adults and adults with physical disabilities go to institutions
- Waitlists for services (as of January 31, 2020)
 - Home-delivered meals 2,697
 - In-home services 1,327
 - Hart-Supported Living 447
 - PCAP 222

Spotlight On: Senior Hunger

- KY rank for food insecurity for ages 60+⁽¹⁾: 39th (16.6%)
- Home-delivered meals
 - ranking⁽²⁾ 46th
 - State funding ↓7% from FY15
- KY has highest rate of food insecurity for ages 50-59⁽³⁾
- KY food insecurity for ages 60+ 10% in past 4 years⁽⁴⁾




(1)America's Health Rankings, 2019: Percentage of adults ages 60 and older who faced the threat of hunger in the past 12 months



Current Issues: Guardianship



- Average caseload 1:60
 - Can be up to 90+
 - Recommended 1:20
- Consequences of high caseloads
 - Lost benefits
 - Utilities disconnected
 - Missed rent payments and eviction
 - Lack of preventive health care
 - Properties falling into disrepair
 - Inability to detect and recoup stolen money
 - Inability to assist individuals in restoring their rights
- Most states have:
 - The ability to decline cases; specific eligibility criteria; and/or caps and waitlists



Initiatives

- Implementing best practices
 - Contract with ADvancing States (national association)
 - Mike Nardone (formerly CMS) assisting with Medicaid admin claiming
 - Kathy Greenlee (formerly Assistant Secretary for Aging) assisting with guardianship
- Implementing person-centered practices
 - Received grant to implement national standards of person-centered practices; 1st state to focus on person-centeredness in state guardianship
- Supporting victims of crime in guardianship
 - Received Victims of Crime Act (VOCA) grant to hire 10 social workers to support individuals under state guardianship who are victims of crime
- Increasing physical activity of homebound older adults
 - Received AmeriCorps grant to pilot Active Choices across state
- Addressing direct care workforce shortage
 - Piloting (with Education & Workforce) internship program for case managers
- Tackling senior hunger
 - Working with community partners, hospitals, KY Agriculture
