Office for Children with Special Health Care Needs

The Agency

The Office for Children with Special Health Care Needs (OCSHCN), a Title V Maternal and Child Health agency, coordinates specialty medical clinics, as well as early intervention services, early hearing detection and intervention services, and family to family services for children and youth with special health care needs and their families, including those with medically complex conditions. OCSHCN was first establish in 1924.


Population Served

Children and Youth with Special Health Care Needs (CYSHCN) are children and youth from birth until 21 years of age who have or are at increased risk for chronic physical, developmental, behavioral, or emotional conditions and who also require health and related services of a type or amount beyond that required by children and youth generally.



Population of Children with Special Health Care Needs

OCSHCN Mission: To enhance the quality of life for Kentucky's children with special health care needs through quality service, leadership, advocacy, education and collaboration.



Total population of children and youth to be served *indirectly* through system strengthening and essential services – accomplished through partnerships and collaborations

Subpopulation of children and - youth who receive enabling and preventive health services from OCSHCN

Subpopulation of children and youth who meet eligibility criteria and are served *directly* in OCSHCN medical clinics or non-clinic encounters

Specialty Medical Clinic Services

Provides multi-disciplinary, medical specialty clinics and/or financial assistance to children from 0-21 years with qualifying conditions including:

- Autism⁺
- Cerebral Palsy
- Cleft Lip & Palate
- Craniofacial Anomalies
- Cystic Fibrosis/Asthma*
- Ophthalmology
- Cardiology

- Hemophilia*
- Neurology⁺
- Orthopedics
- Otology
- Audiology Services
- Therapy Services



Each child/family enrolled receives <u>Case Management/Care Coordination</u> from a Registered Nurse. They have access to social workers, family support, and nutritional services when needed.



- Extension for Community Healthcare Outcomes (ECHO) Autism Project
 - Collaboration with Kentucky's expert pediatric specialists
 - Education is provided to Primary Care Physicians, Family Practitioners, Psychiatrists, and Psychologists to empower them to care for children with Autism in their communities
 - Developmental Screening (As Requested)

Population Served

Specialty Medical Clinic, Audiology, and Therapy Services

- In FY20 and FY21...
 - Total services provided 74,489 (FY20), 65,512 (FY21)
 - Total unduplicated patients seen 7,445 (FY20), 6,212 (FY21)
 - Impact of the COVID-19 Pandemic

Early Hearing Detection and Intervention (EHDI)

- In FY21...
 - 49,256 (98%) newborns were screened
 - 1,279 newborns were referred for follow-up
 - 799 newborns were directly enrolled into OCSHCN Otology Services

Family to Family Health Information Center

- 127 Parents Trained
- 708 Trainings Provided
- 17,671 Materials Distributed



Kentucky Early Intervention Services KIPDA Region

OCSHCN is responsible for Kentucky Early Intervention Services in the KIPDA region. The program ensures provision of early intervention services to children from birth to age 3 and their families. Comprehensive services are offered through a variety of community agencies and service disciplines.

- In 2021, OCSHCN/KIPDA POE received 2,883 referrals
- 1,373 of the referred children were eligible for Early Intervention Services
- The KIPDA POE provided services to 3,203 additional children.
- KIPDA Point of Entry transitioned all children of consenting families to Part B services with their Local Education Agency/Preschool at age 3.




