What is KPAP?

KPAP's Mission is Twofold:

Consolidate all National Prescription Assistance Programs (PAPs)

Into one location that is easily accessible by volunteer advocates into a large cloud database offered by:

Drug Manufacturers

Discount Medication Programs Discount Pharmacy Programs

Enroll, Train & Assist Community Advocates to Serve Kentuckians

Obtain FREE or REDUCED-COST prescription drugs offered by national PAP initiatives

Connect those in need with local organizations that provide all forms of basic life needs when possible

National Prescription Assistance Programs (PAP)

Program Providers

- Drug manufacturers
- Discount medication programs
- Discount pharmacies
 that offer national prescription assistance programs (PAPs) which allow patients to receive

 FREE or LOW-COST MEDICATIONS

PAP Applications

Each program provider has its own qualifying standards for approval:

- Majority based on:
 - Household income levels
 - Insurance coverage
- "Company specific" set of rules, qualifications, varying amounts of information and paperwork required for application(s)

Who Is Eligible For KPAP?

Individuals with different income levels

Senior citizens in the Medicare "donut hole" Insured individuals whose current medications are not covered by their health insurance

Those not eligible for existing drug assistance programs receive consultation about other sources of low-cost prescription opportunities such as:

- 1 Co-pay assistance
- 2 NeedyMeds



Advocate Process with Patients

New Client

Enter patient demographics into the software including: contact info, financial, insurance, health, treatment, etc.

Create New PAP Order

Research medications for enrollment availability, complete order form, identify refill reminder & follow-up dates, & documents to include like the IRS 4506-T form.

Print Application

Review the application for correct info, use a yellow highlighter to mark the area for the provider to sign quickly, remind the patient to date/sign & the provider sign ASAP.

Submit the Application

When patient returns paperwork to you, verify the dates/ signatures are included, double-check application is fully completed with required document(s), then mail or fax in.

Denied Applications

Review information for denial.

Information could be incorrect or the patient income is above the limit.

Identifying monthly medical expenses can help the drug manufacturer in making an exception on occasion.

Refills & Follow-Ups

Once the patient is approved for 1year into the drug program, refills
will need to be done every 3 months
for that drug & reminders will
show up in Drug Assistant.

KPAP Outcomes


- Improves access to free/reduced cost prescription medications
