## Why Support the KY Craft Brewing Industry ?

Small businesses make up: **99.7**% of U.S. employers, **64**% of net new privatesector jobs, and **98**% of business exporting goods.

KY craft brewers are a significant manufacturing sector in KY, creating new job opportunities, investments and growing new industries while supporting Kentucky's economy.


The craft brewing industry is no longer just a urban industry. Kentucky has craft brewers in both rural and urban areas across the Commonwealth revitalizing distressed properties, building and supporting communities and creating direct manufacturing, tourism and retail sector jobs while supporting a host of indirect jobs and industries.

KY tourism revenue is up. As is interest in KY craft beer festivals and events bring in tourist from all over the nation. 2018 KY Craft Bash still in its infancy, brought in over 1400 people, from 16 different states -1/3 of the US, selling out hotel room blocks at the Omni, and event sales were up 45%.

### DIRECT IMPACT

KY Craft Brewers continued growth results in direct economic impact in the Commonwealth:

- Investment of new dollars in Kentucky.
- KY based Infrastructure.
- Industry revenue & sales.
- Wages & benefits to Kentuckians they employ.
- Tax revenue (Federal, State & Local).





#### Kentucky's Craft Brewers Continued Growth & Economic Impact





- KY now has 62 licensed craft /microbreweries representing over 50 different KY companies. 14 additional new breweries, have either opened or are currently in planning stages to open (8 in planning) since January 2018.
- 31 breweries have expanded to the tune of an additional \$22 million in KY investment. 25 additional breweries are in expansion planning which would add an additional \$6.9 million for a new investment total of \$ 28.9 million.
- KY craft beer has an annual economic impact of \$657 million for the Commonwealth. KY ranks 27<sup>th</sup> in the nation on positive economic impact for our state- even though we rank 40<sup>th</sup> for the number of breweries located in our state.
- KY craft brewers export to more than 42 states and over 25 countries.
- Continue gaining positive results from global trade trips.

## Kentucky's Growth & Economic Impact cont.







- KY craft brewers now directly employ more than 800 Kentuckians. Added an additional 147 new jobs since January 2018.
- Our KY brewers projected production is approximately 151,000 barrels. A 50% increase since 2016 and 21% jump over 2017 production.
- KY new craft brewers and existing brewers expansions have continued to lead to the location, creation and expansion of various NEW support industries now in the Commonwealth.
- Our brewers partner with the KY Department of Agriculture, Local Farmers, KY Tourism, Arts and Heritage Cabinet and Kentucky's Economic Development Cabinet to advance the Commonwealth.
- Enhance tourism through synergies with our KY Distillers (Willett partnership and the KY Proud Beer Series) etc.
