# NCCI Advisory Loss Cost Filing

- National Council on Compensation Insurance
- Loss cost (reflecting indemnity and medical benefits) based on policy years 2016 and 2017
- Report to Commissioner of the Department of Insurance
- Advisory loss cost filing used by insurance carriers for reference in determining workers' compensation insurance rates
- Proposed overall average voluntary loss cost level change of -9.0%
  - Increase of 6.2% for surface coal mining
  - Increase of 5.5% for underground coal mining

2018: -10.8%2017: -4.6%2016: -5.0%

# 2020 Special Fund Assessment

- The assessment rate is established by the Kentucky Workers' Compensation Funding Commission as a funding source for:
  - The Special Fund
  - The Uninsured Employers Fund
  - The Kentucky Labor Cabinet

2020 rate: 6.41%; no additional assessment on coal employers; no additional assessment on severed coal


- 2019 rate: 6.41% with additional 2% assessment for coal employers and \$.02 per ton of severed coal
- 2017 and 2018 rates: 6.29% with additional 14% for coal employers and \$.15 per ton of severed coal



2019 (through August 31): 2,602 (annualized = 3,903)









### Occupational Disease Claims by Calendar Year (2002-8/31/19)

## House Bill 2 update

Pharmaceutical formulary: Adopted ODG formulary effective July 1, 2019 for post-2018 injuries and January 1, 2020 for pre-2019 injuries.
 803 KAR 25:270

- Medical treatment guidelines: Adopted ODG treatment guidelines; proposed effective date is July 1, 2020; Public hearing November 21.
  - 803 KAR 25:260

<u>CWP evaluation program</u>: DWC contracted with two qualified physicians to perform evaluations required by KRS 342.316.

- 211 claims filed since July 14, 2018;
- Evaluations are currently being performed within 60 days of claim filing;
- No backlog.
