
Dear Mr. Reece:

The 2018 Regular Session of the General Assembly enacted House Bill 200 the Executive Branch Budget bill. This bill contains various requirements for reporting to legislative committees, some of which are new requirements. The following requirement affects your cabinet:

**Fees-in-Lieu-of Stream Mitigation Reporting:** The Department of Fish and Wildlife Resources shall develop a report of all projects managed by the Fees-in-Lieu-of Stream Mitigation Program. The Department shall present this report to the Interim Joint Committee on Tourism, Small Business, and Information Technology by August 1 of each year. (New reporting requirement in HB 200 page 99)

Please contact your budget analyst if you need assistance in understanding reporting requirements or determining a report format and content. Please note that your cabinet may have other reporting requirements that are not contained in this bill. Please provide copy of this report to our office.
