


Clay City Business Park Funding Justification

- 1. Lot of exciting projects going on in Powell County right now in terms of Industrial Growth which has resulted in our county being out of marketable industrial land. We would like to hi-light a few of our manufacturing success stories which have created the need for the development of the Clay City Industrial Park:
- 2. Tebco, a truck body manufacturing operation:
 - a. Began their operation in Powell County in 2020 by locating in a 30,000 sq. ft. building & another 15,000 sq. ft. building in the Stanton Industrial Park.
 - b. In 2024 they expanded to a third 50,000 sq. ft. building in the county
 - c. In 2025 they purchased the last lot in the Stanton Industrial Park, which took our last available marketable industrial site.
 - d. Tebco now employs approximately 120 people throughout their 3 locations in Powell County and anticipate additional expansion needs.
- 3. Powell Valley Millwork (leading manufacturer of interior moldings, millwork and trim boards) is located in Clay City, Kentucky
 - a. Governor just announced their \$29.6 million investment across their plants in Clay City and Jeffersonville that will allow them to update their operational capacity and equipment in the wood industry.
 - b. They currently employee 150 at the Clay City facility and will add new jobs with the expansion that was just announced.
- 4. In 2025 we have helped another one of our local companies, Red River Ranch expand and create another 35 jobs in our county.
- 5. Gas Bowstrings, a world renowned Bowstring manufacturer:
 - a. Started in 2017 and are now employ 57 people.
 - b. They are continuing to grow and are currently expanding into an additional 5,000 sq. ft. space at their current location.
 - c. They however really need a new 30,000 sq. ft. building in order to be able to accommodate the company's current growth needs
 - d. Their desire is to locate in the Clay City Industrial Park due to its proximity and visibility from the Mountain Parkway.
- 6. Clay City Business Park approximately 30 acres
 - a. Powell County has aggressively worked to help ourselves
 - b. We were successful in getting the Park into a designated opportunity zone where businesses could take advantage of potential tax incentives
 - c. The County used a big chunk of its ARPA money to get the engineering done for the property
 - d. Water and sewer plans have been completed by Nesbitt Engineering


- e. Archaeological work is completed
- f. Preliminary road design is done
- g. In addition to Gas Bowstrings, we have at least two more businesses that are interested in locating in the park
- h. We desperately need your assistance in order to help us move this property to the next level so that it can accommodate actual business development.
- i. We respectfully request \$4 million to finalize the infrastructure for the property so that we can once again market Powell County to Industrial clients.





The total population of Powell County is 13.040. The median age is 38.54




Population Growth (in thousands)




Businesses and Jobs

What are the top industries by jobs?





How many employees do businesses in Powell County have?




Income and Spending


How do people spend most of their money?
