



Dependency, Neglect and Abuse Cases Filed FY 2015 - 2019 Statewide



THEMES FROM COMMUNITY FORUMS

- Frustration with lack of communication and training
- Frustration with agency process and court process
- Frustration with available and accessible support/services



Communication and Training

- Children, parents, and caregivers need timely, complete, and accurate information about:
 - Agency and court process in general
 - Status, progress, and reasonable expected outcome of the case
 - Availability, necessity, and benefit of services and resources
- Also need help facilitating communication other

between each



Communication and Training

• Foster parents reported a lack of information about:

- Available Independent Living Skills services
- Educational challenges and terminology (leveling)
- Court dates, and whether the child should be present
- Child's needs
- Visitation schedules and changes
- Trauma, its impact on the child, and strategies to help child
- Support services/groups
- Financial resources



Communication and Training/Specific Training Needs

For Foster Parents:

- Agency and court process
- Accessing court and the roles of parties, attorneys, professionals
- Accessing educational and monetary resources for children
- Accessing support for foster parents
- Role of foster parents

For CASA Volunteers:

Specialized training for medically fragile children



Agency/Court Process Concerns

- Youth are frustrated when placed outside their home counties
- If allegations are unsubstantiated, children should be returned
- There should be measures in place to prevent additional trauma from happening while child is in state's custody
- Relatives should be identified as soon as possible
- Parent's case plans are overwhelming (should be incremental)
- Lack of Family Court in each county



Agency/Court Process Concerns

- Foster parents should be drug tested
- Foster parents should be the "right fit" for the child, not vice versa
- Foster parents should advocate for child's return instead of working against the biological parent
- Out-of-state placements take too long (red tape and lack of communication)
- Parties, agencies, and attorneys should participate in Interested Party Reviews
- Children's attorneys should regularly communicate with the child



Agency/Court Process Concerns

- Termination of parental rights (TPR) taking too long
- Adoption taking too long
- Lack of voice in process
- Too many reunifications
- Children removed for maltreatment in foster home
- Inability to make medical and educational decisions for child
- Inability to make day-to-day decisions (sports, cell phone, sleepovers,
 - etc.)
- Delays in receiving contracts and reimbursements

Needed Services/Support

- Preventative services for biological families to prevent unnecessary removals
- Reunification services for parents who are incarcerated short-term
- Transportation services for parents to complete plan
- Interpreter services
- Immediate trauma-informed therapy for children upon removal
- Counseling for children on how to manage uncomfortable social situations

Needed Services/Support

- Mentors/Peer-Support for every stakeholder
 - Life coach for children
 - Parent aide or peer-support for parents and care-givers
- Post-adoption services for children
 - Children sometimes lose their provider/services (Better off if committed)
- Quicker assessments or more assessors
 - Assessments ordered for mental health, substance abuse, etc.; sometimes take months for report
- Financial support for relatives and fictive kin

Current CFCRB Legislative Recommendations

- Statewide Expansion of Family Courts to each Judicial Circuit
 - The CFCRB has historically regarded the statewide expansion of Family Court as a high priority due to improved outcomes for families and children who have access to expanded services provided by Family Court. To further this cause, the CFCRB would support a future judicial redistricting plan that brings Family Court to every county in the Commonwealth.
- Increase funding for DCBS that is dedicated to securing and maintaining sufficient local staff to work caseloads
- Amend KRS 620.190(e) to allow non-DCBS employees of CHFS to serve on local boards. Suggested language:
 - (e) Employees of the cabinet <u>Department for Community Based Services</u> shall be prohibited serving on the local citizen foster care review board






