

- Assure all children have safe and nurturing homes and communities; ...





# Background Checks Process Proposed with National Background

#### Current/922 KAR 1:490

- Hardcopy DPP-157/159 completed
- Prospective foster/adoptive parent (FAP) fingerprinted in DCBS local office
- **DCBS** Records Management Section (RMS) runs child abuse and neglect check (CA/N) and matches criminal check results with DPP-157/159
- Fitness determination made by DCBS
- Private child-placing agencies can have person qualified to receive rap sheet under Adam Walsh certification
- RMS stores check results for federal audit purposes
- Annual in-state criminal and CA/N checks through worker/private agency and RMS

## **Check Program**

- Online application made
- CA/N check
- Upon clear CA/N check, FAP given form for fingerprinting, including closest sites
- Automated approval if no findings
- RMS will make fitness determination in system with electronic notice of determination sent to private childplacing agencies
- Provision of rap sheet to rep of private agency with Adam Walsh certification
- Results stored for 5 years for audit purposes
- 5 year rap back for in-state criminal and CA/N



#### **Initial Foster Parent Approval**

Applicants must:

- Have a complete home study
- Provide proof of age, US citizenship, and valid driver's license and insurance
- Obtain a report of positive health
- Verify income
- Provide personal and credit references
- Verify marriage, divorce, or death of spouse
- Pass a background check (KRS 199.462, 922 KAR 1:490)



#### **Pre-Service Training**

- A foster or adoptive parent applicant shall complete a minimum of fifteen (15) hours of curricula in topics outlined in 922 KAR 1:495
- In addition, applicants are required to complete (5) five web-based trainings (WBT)
- In general, WBTs and pre-service are completed concurrently
- The private agency or DCBS workers typically fingerprint the applicant at the first pre-service training to speed up the approval process



### **Ongoing Training**

Prior to or during the month of the second anniversary date of a foster or adoptive parent's initial approval, the foster or adoptive parent shall complete a minimum of thirty (30) hours of training in the following areas:

- Trauma informed care
- Psychotropic medications
- Sexual abuse
- Behavior management and skill development



### **Ongoing Training**

Annual ongoing training:

- Families are required to complete 10 hours:
  - Fifty percent must be in class and fifty percent may be completed online
  - Not a prescribed curriculum and families may choose training that best supports their ability to care for the children they are caring for at that time



- Amended administrative regulations and policies to further align foster home standards
- Implementation of online foster parent registry
- Implementation of child-specific foster home type for relatives and fictive kin
  - Waiver for non-safety standards
  - Option for reduced training
  - Training curriculum is tailored to the needs of relative/fictive kin caregivers





- Diligent recruitment
  - Specific to needs in each service region
  - Targeted recruitment strategies
  - Increased focus on retention strategies
  - Ensuring access to informational meetings, trainings, and home studies
  - KY FACES portal <u>kyfaces.ky.gov</u>



- Amended 922 KAR 1:310 and 922 KAR 1:350 to remove annual re-evaluation requirements
- Notified other public agencies and private providers of the changes in minimum requirements
- Issued policy implementing the changes




- Re-evaluation requirements include a home visit, interview with the foster parents, and paperwork
- DCBS is working towards a solution that would allow background checks to be conducted less frequently (constant rap back for 5 years)
