2	New Section	 Establishes the Kentucky Public Pensions Authority (KPPA) whose purpose shall be to administer and operate: (1) a single personnel system for CERS and KRS; (2) a system of accounting for CERS and KRS; (3) day to day administrative needs of KRS and CERS including, but not limited to, benefits counseling and administration, information technology including developing a centralized website for KRS and CERS, legal services, employer reporting and compliance, benefit/accounting/investment administration as directed by the KRS and CERS Boards, and completing and compiling financial reports; (4) any jointly held assets used in the administration of the systems such as land, buildings, equipment, etc.; and (5) other tasks and duties directed solely or jointly by the KRS and CERS Boards.
